#### CONSTITUTION OF BOTSWANA

#### Authorization to Excercise Functions of Office of President

TO: THE HONOURABLE PETER SIMAKO MMUSI, M.P., VICE-PRESIDENT AND MINISTER OF FINANCE AND DEVELOPMENT PLANNING

WHEREAS it is provided by section 36 (1) of the Constitution that whenever the President is absent from Botswana or considers it desirable so to do by reason of illness or any other cause he may, by directions in writing, authorize the Vice-President to discharge such of the functions of the office of President as he may specify and the Vice-President may discharge those functions until the President's return to Botswana or the revocation of such authorization, as the case may be;

AND WHEREAS I intend to be absent from Botswana from 27th October, 1986, and I consider it desirable to issue directions as aforesaid;

NOW THEREFORE, in exercise of the powers vested in me as aforesaid I authorize you, PETER SIMAKO MMUSI in your capacity as Vice-President and Minister of Finance and Development Planning, to discharge with effect from 27th October, 1986 all the functions of the office of President, except —

- (a) the power to dissolve Parliament in accordance with the provisions of section 91 of the Costitution:
- (b) the power to appoint to the office of Minister or Assistant Minister in accordance with the provisions of section 42 of the Constitution:

Provided, however, that you can appoint the present Ministers or Assistant Ministers to act in place of any Minister who is otherwise not available;

(c) the power to remove a Minister or Assistant Minister from office in accordance with the provisions of section 43 of the Constitution;

until my return to Botswana or this authority is revoked by me whichever happens first.

AND WHEREAS the people of BOTSWANA, from all walks of life, are, today, on this TWENTIETH ANNIVERSARY, and in remembrance of that GLORIOUS day when the FIVE STRIPED NATIONAL FLAG OF BOTSWANA was proudly hoisted and the ENSIGNS ARMORIAL OF BOTSWANA adopted, as the PERMANENT symbols of FREEDOM AND NATIONHOOD, celebrating in song, food, drink, play and divers other activities;

AND WHEREAS we commend the sick, the lame and the bereaved, who are not able to join their brethren in song, food, drink, play or divers other activities to the HEALING HAND of the ALMIGHTY GOD;

AND WHEREAS in exercise of the POWERS conferred on ME by the CONSTITUTION of the REPUBLIC OF BOTSWANA, I intend, as a gesture of GOODWILL and MERCY, to remit in part, punishments imposed on persons serving determinate sentences;

NOWTHEREFORE, I QUETT KETUMILE JONI MASIRE, PRESIDENT OF THE REPUBLIC OF BOTSWANA do by THESE PRESENTS ORDER and PROCLAIM that all prisoners serving determinate prison sentences and who have been adjudged to be of good conduct shall have part of their prison sentences remitted as follows:

(a) SENTENCES	REMISSION
1 - 6 months	1 month
7 — 12 months	2 months
13 — 36 months	6 months
37 - 72 months	12 months
73 — 120 months	20 months
Over 120 months	24 months.

- (b) The remission shall apply only to those prisoners serving their sentences as of this 30 day of September, 1986.
- (c) The remission shall take effect from the 31st day of October, 1986.
