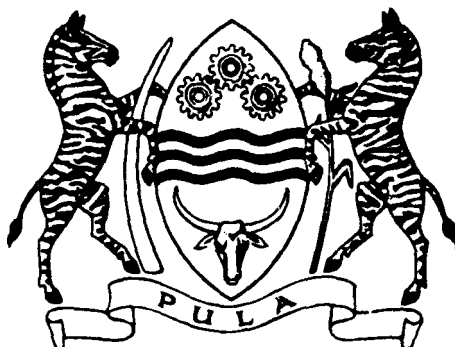

**MEMORANDUM**

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. The Bill seeks to ensure that a public officer who could have retired and received a gratuity and pension, was not deprived of those retirement benefits by his death occurring while he was still in service. It provides for the payment to his legal personal representative of a gratuity and a death grant equivalent to three year's pension.

3. The Bill further provides that where a pensioner dies within certain periods of his retirement, his legal personal representative will be paid a gratuity varying according to how long after retirement the officer dies.

- (b) a death gratuity equivalent to twice the annual amount of the pension of the deceased officer where the officer dies more than ten years but less than fifteen years after his retirement;
- (c) a death gratuity equivalent to one year's annual amount of the pension of the deceased officer where the officer dies more than fifteen years after his retirement."
