**LIQUOR ACT**  
(Cp. 45:01)

**Liquor Licences (Extension of Period of Duration) Order, 1986**

WHEREAS it is provided section 61 of the Liquor Act that any person or authority vested with a power to allow, give consent to grant or revoke any matter or thing under the Act, may by direction of the President, allow or disallow, give or withhold his consent, grant or not grant or revoke or not revoke that matter or thing;

AND WHEREAS the liquor licences in respect of the applications specified in the Schedule hereto expire on the 31st December, 1986;

AND WHEREAS special circumstances have rendered it impracticable to comply with the requirements of section 16 of the Liquor Act to hold special sittings of licensing courts to consider the said applications for renewal before the 31st December, 1986;

AND WHEREAS I consider it conducive to the public good to grant the application for the renewal of the said licences;

NOW THEREFORE in the exercise of the powers vested in me and in accordance with the directions of the President, the applications for renewal of licences specified in the Schedule hereto are hereby granted for a period of two months with effect from 1st January, 1987.
