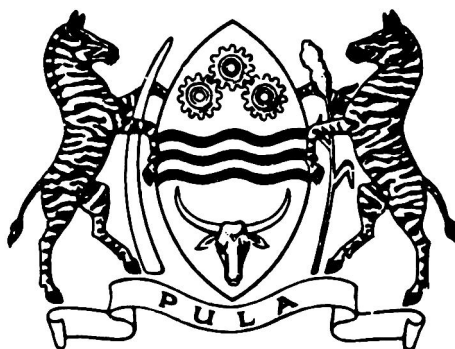

ARRANGEMENT OF REGULATIONS

REGULATION

1. Citation
2. Amendment of regulation 11 of Cap. 40:02 (Sub. Leg.)
3. Amendment of regulation 12 of principal Regulations

IN EXERCISE of the powers conferred on the Minister of Local Government and Lands by section 3 of the Townships Act, the following Regulations are hereby made

1. These Regulations may be cited as the Town Councils (Amendment) Regulations, 1987. Citation
2. Regulation 11 of the Town Councils Regulations (hereinafter referred to as "the principal Regulations") is hereby amended as follows Amendment of regulation 11 of Cap. 40:02 (Sub. Leg)
 - (a) by substituting for subregulation (1) thereof, the following new subregulation (1) —
 - " (1) There shall be a Mayor for each council who shall be elected by secret ballot from among the members of the council by the members present, and such election shall be the first business transacted at the first meeting of the council and thereafter annually"; and
 - (b) by substituting for subregulation (5) thereof, the following new subregulation (5) —
 - " (5) The nomination of a candidate for election to the office of Mayor shall be made on a nomination paper which shall therein specify the names of the candidate, the proposer, the seconder and two supporters, none whom shall at the same time be the candidate, the proposer, the seconder or other supporter:
Provided that where a council has less than ten voting members, it shall be sufficient that the nomination of a candidate for the office of Mayor is supported by at least one member who shall not at the same time be the candidate, the proposer or seconder."
3. Regulation 12 of the principal Regulations is hereby amended by substituting for subregulation (1) thereof the following new subregulation (1) — Amendment of regulation 12 of principal Regulations
 - " (1) There shall be a deputy Mayor for each council who shall be elected by the secret ballot from among the members of the council by the members present. The nomination of a candidate for election to the office of deputy Mayor shall follow immediately after the election of the Mayor and the nomination shall be made on a nomination paper which shall therein specify the names of

the candidate, the proposer, the seconder and two supporters who shall not at the same time be the candidate, the proposer, the seconder or other supporter:

Provided that where a council has less than ten members, it shall be sufficient that the nomination of the candidate for the office of deputy Mayor is supported by at least one member who shall not at the same time be the candidate, proposer or seconder."
