# TRIBAL TERRITORIES (AMENDMENT) BILL, 1987

(Published on 20th February, 1987)

### **MEMORANDUM**

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

- 2. The main object of the Bill is to amend the Tribal Territories Act in consequence of the Government giving portion 4 of the Farm Moroekwe 4-JO to the Bamalete Tribe as compensation for the loss of the Tribal Grant 21-KO from the remainder of Forest Hill 9-KO for the purpose of raising the Gaborone Dam wall.
- 3. Clause 2 therefore provides that Portion 4 of the Farm Moroekwe 4-JO should be designated as a tribal land and incorporated in Bamalete Tribal Territory, whilst clause 3 also provides that the land acquired from the Bamalete Tribe, namely, Tribal Grant 21-KO, shall cease to be part of the Bamalete tribal land.
- 4. Clause 4 therefore amends section 7 of the Tribal Territories Act which relates to Bamalete Tribal Territory by incorporating portion 4 of the Farm Moroekwe 4-JO in the tribal territory and deleting from the description of the boundary of that territory, the Tribal Grant 21-KO.

Short title

1. This Act may be cited as the Tribal Territories (Amendment) Act, 1987.

Designation of land as tribal land 2. Portion 4 of the Farm Moroekwe 4—JO shown on diagram DSL No. 144/85 is hereby designated a tribal land and shall form part of the Bamalete Tribal land.

Designation of land as non-tribal land 3. The portion of land known as Tribal Grant 21-KO, granted by the Bamalete tribe to the Government from the remainder of Forest Hill 9-KO, shall cease to be a tribal land and consequently shall not longer form part of the Bamalete tribal land.

Amendment of Cap. 32:03 4. In consequence of the preceding provisions of this Act, section 7 of the Tribal Territories Act is hereby amended —

- (a) by incorporating in the description of the boundary of the Bamalete Tribal Territory, portion 4 of the Farm Moroekwe 4-JO referred to in section 2; and
- (b) by deleting from the said description of the boundary referred to in paragraph (a), Tribal Grant 21-KO referred to in section 3.
