#### **COMMISSION OF INQUIRY**

(Cap. 05:02)

**Appointment of Commission of Inquiry** 

WHEREAS certain allegations have been made in the National Assembly by Mr G. S. Mosinyi, Member of Parliament regarding the administration of the Prisons Department;

AND WHEREAS these allegations would if proved constitute matters of grave concern to the good government of this country;

IN EXERCISE of the powers conferred on the President by section 2 of the Commission of Inquiry Act the following Commission is hereby issued —

#### **COMMISSION**

- 1. I hereby appoint Mr Benjamin Gaontebale Makobole as Commissioner to inquire into the matters specified in paragraph 2 thereof.
- 2. The Commissioner is hereby empowered and authorised to enquire into the following matters in which an enquiry would, in the opinion of the President, be for the public welfare:

Allegations of irregularities in the administration of and personal relations within the Prisons Department, and in particular but without limitation to the generality of the foregoing, to investigate—

- (a) allegations of sexual harassment of female employees by senior male officers of the department;
- (b) whether there has been ill-treatment of junior officers by their seniors and the denial to such junior officers of training opportunities and whether these factors may have caused mass resignations from the prison service;
- (c) whether officers are being disciplined by being transferred;
- (d) whether substantial sums of money are owing from senior officers to the junior mess and, if so, from which officers;
- (e) whether any officer was promoted and then within eight months or so of his promotion, dismissed from the prison service and, if so, whether his dismissal was for good cause;
- (f) whether the Deputy Commissioner -
  - (i) assaulted officer Mr Raloka and if so, for what reason,
  - (ii) is himself personally principally responsible for many of the complaints made by the employees of the prison service.
- 3. The Commissioner will be acting under the Commissions of Inquiry Act and shall have all the powers conferred and all the duties imposed by that Act.
- 4. The Commissioner shall sit at such place as the Permanent Secretary to the President shall determine but shall have the power to visit any place, conduct inspections in loco and to sit at such place and at such times as the Commissioner shall deem appropriate for the performance of his duties.
- 5. The Commissioner shall commence his inquiry immediately and shall complete and report back to the President as soon as praticable thereafter.
- 6. I do hereby appoint Ms Godisang Mookodi to be secretary of this Commission and to perform such of the duties set out in the Act as she may be called upon by the Commissioner to perform.
