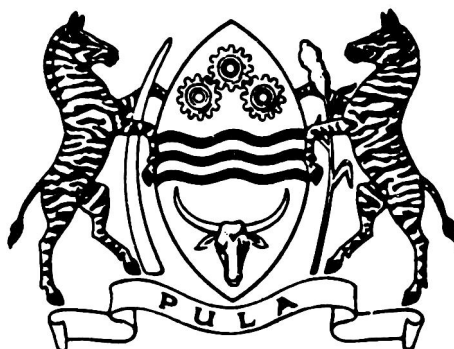

INCOME TAX ACT

(Cap. 52:01)

Income Tax Returns-Tax Year Ending 30th June 1987

IN ACCORDANCE with section 64 (2) of the Income Tax Act, notice is hereby given that every person liable to furnish a tax return for the tax year ending 30th June, 1987, is required to furnish such return to me in the prescribed form within two months of the end of that tax year.

2. Subject to paragraph 3 hereof the following persons are liable to furnish a tax return —

- (a) every person liable to pay tax;
- (b) every partnership;
- (c) every employee or other individual whose chargeable income exceeds the annual rate of P1 200 during the tax year;
- (d) every trustee of a person under a legal disability or executor of a deceased person where the chargeable income of that trust or estate exceeds the annual rate of P1 200 during the tax year;
- (e) every company, every trustee of a trust or of an insolvent estate and every non-resident to whom any chargeable income has accrued during the tax year;
- (f) every person who in any previous tax year has made a loss in respect of which he may be entitled to claim a deduction in the tax year or any subsequent tax year;
- (g) every person who was liable to pay tax in respect of the previous tax year; and
- (h) every person who is notified by the Commissioner in writing, that he is required to furnish a tax return.

3. Except where the Commissioner has given written notification that a tax return is to be furnished a person noted in paragraph 2 is not liable to furnish a tax return if that person was —

- (a) a non-resident whose only income was subject to and has been subjected to deduction of tax under section 58;
- (b) a married person whose chargeable income did not exceed P11 500 and was wholly subjected to withholding of tax under section 56;
- (c) an unmarried person whose chargeable income did not exceed P9 500 was wholly subjected to withholding of tax under section 56; or
- (d) advised by the Commissioner in writing that a tax return is not required to be furnished.

4. Tax returns may be obtained from —

- (a) Income Tax Assessment Office, Private Bag 0013, Gaborone;
- (b) Income Tax Assessment Office, Private Bag 38, Francistown;
- (c) Income Tax Assessment Office, Private Bag 7, Serowe;
- (d) Income Tax Assessment Office, Private Bag 13, Selebi-Phikwe;
- (e) Any District Commissioner's Office; or
- (f) Any Post Office,

and it is the duty of all persons liable to furnish a tax return to obtain such a form.

5. Completed tax return forms should be delivered or posted to the Department of Taxes, Private Bag 0013, Gaborone, or to the Department of Taxes, Private Bag 38, Francistown, or to the Department of Taxes, Private Bag 7, Serowe, or to the Department of Taxes, Private Bag 13, Selebi-Phikwe.
