Commencing at a point "A", approximate co-ordinates $Y = 80600 \times = 69800$, situated to the south east of a settlement called Nxakato and near the eastern edge of a track meeting the Francistown-Nata Road at a place called Semowane, to the north, and crossing the River Mosetse at Tshuane, to the south, the boundary runs in a south-easterly direction for a distance of approximately 3,6 km to a point "B", approximate co-ordinates $Y = 77200 \times = 71000$; thence continues in a south-easterly direction for an approximate distance of 3,5 km to a point "C", approximate co-ordinates $Y = 74700 \times = 73400$, situated to the north of a track from Tutume crossing the Francistown-Nata road near Mhatane; thence southwards for an approximate distance of 10.1 km to a point "D", approximate co-ordinates Y = $77400 \times = 83100$; thence in a westerly direction for an approximate distance of 14,6 km to a point "E", approximate co-ordinates $Y = 91800 \times = 80500$; thence in a north-easterly direction for a distance of approximately 11,4 km to a point "E", approximate co-ordinates $Y = 85000 \times = 71400$; thence continuing generally in a south-easterly direction for a distance of approximately 4,7 km to the point of commencement, as will more fully appear on Plan OP 3 deposited with the Director of Surveys and Lands. - 2. The errors appearing in section 10(1) of the Matimela Act are hereby rectified —
- (a) by substituting for the words "may, notwithstanding that" appearing after the word "kraal" therein, a comma;
- (b) by inserting the word "a person" immediately after the words, "such matimela or" appearing therein; and
- (c) by inserting the word "may" immediately after the words "the Hypothecation Act," appearing therein.

3. The errors appearing in sub-subparagraphs (ii)-(iv) of sub-paragraph (h) of paragraph 2 of Part I of the Sixth Schedule to the Income Tax Act is hereby rectified by substituting for those sub-subparagraphs the following —
