ACCOUNTANT'S ACT 1988

Botswana Institute of Accountants

The Accountants Act 1988 will come into effect on July, 1990. The Act provides at section 19(1) that no person shall practice as a public accountant in Botswana unless he is an Associate or Fellow Member of the Institute with an office or place of business in Botswana and has obtained a practising certificate from the Council of the Botswana Institute of Accountants. Any person practising as an auditor at the date of the commencement of the Accountants Act shall be entitled to continue so to practise without registration for a period of only 90 days from July 2nd 1990. Thereafter all auditors must be in possession of a practising certificate.

The Act provides at section 16 (5) that any person resident and working in Botswana who is a member in good standing of an institute or association of accountants which is a member of the International Accounting Standards Committee or the International Federation of Accountants shall register as an Associate Member of the Institute within 90 days from either the date of commencement of this Act or of taking up residence in Botswana.

Any citizen of Botswana who at the date of commencement of this Act has practised as an accountant for a period of at least five years shall be entitled to be registered as a member of the Institute upon application made by him within 90 days of the commencement of this Act.

INCOME TAX ACT (Cap 52:01)

INCOME TAX (EMPLOYMENT INCOME) REGULATIONS, 1990 (Published on 15th June, 1990)

IN EXERCISE of the powers conferred by section 141 of the Income Tax Act, the Minister of Finance and Development Planning hereby makes the following Regulations-

1. These Regulations may be cited as the Income Tax (Employment Income) Citation and Regulations, 1990, and shall apply to the assessment of employment income for the tax year commencing on the 1st July, 1990, and for all subsequent tax years.

2. The current capital valuation referred to in section 30 (3) (c) of the Income Current Tax Act shall be calculated by multiplying P250 by the gross floor area in square capital metres of the quarters or residence concerned (that is to say the total floor area valuation measured over all external and internal walls), as at the commencement of the tax year, or as at the date of completion of the construction of the property in question if such completion occurred during the tax year:

Provided that, where the Commissioner is satisfied that, by reason of the standard of building, an excessive current capital valuation results, he shall, in place of the factor of P250, apply such smaller factor, but being not less than P170, as he considers fair and reasonable.

3. The relevant percentage of employment income, excluding the value of the Relevant provided quarters or residence, of an employee for the purposes of paragraph (ii) percentate of employment of the proviso to section 30 (3) of the Income Tax Act shall be 1% of the amount income in respect of which the rate of tax in Table I of the Tenth Schedule of the Act is zero, plus 0,25% of every additional amount of P100, subject to a maximum of 25% of such employment income.

IN EXERCISE of the powers conferred by sections 3 (2) and 23 of the Sales Tax Act, the Minister of Finance and Development Planning hereby makes the following Regulations — 1. These Regulations may be cited as the Sales Tax (Amendment) (No. 4) Citation

Regulations, 1990.

2. The Sales Tax Regulations are amended by substituting for regulation 9 Substitution for regulation —

"Exemption 9. Notwithstanding regulation 8, any person entering Botswana by air, rail or road may import, at the time of his entry, in his physical possession and for his own personal consumption, any goods specified in Parts I and II of the First Schedule, up to a total value not exceeding UA 500, without payment of sales tax.".
