**SCHEDULE**

IN EXERCISE of the powers conferred on the Minister of Commerce and Industry by section 3 of the Control of Goods, Prices and Other Charges Act, the following Regulations are hereby made —

| <p>1. These Regulations may be cited as the Control of Goods, Prices and Other Charges (Petroleum Prices) Regulations, 1991, and shall come into force on the 29th March, 1991.</p>   | <p>Citation and Commencement</p>           |
| <p>2. In these Regulations "the levy" means the levy imposed by the Control of Goods (Petroleum Products) (Levy) Regulations, 1979 and the Control of Goods, Prices and Other Charges (Petroleum Products) (Levy) Regulations, 1986.</p>  | <p>Interpretation</p>                      |
| <p>3. No person shall sell by retail, either in person or through an agent or employee —</p> <p>(a) at any place specified in the first column of the Schedule, the petroleum product specified at the head of the second, third, or fourth column of the said Schedule at a price exceeding the amount per litre specified in relation to that place in that column which amount includes —</p> <p style="margin-left: 20px;">(i) in respect of petrol levies of two and four thebe per litre payable in respect of the National Petroleum Fund and the Motor Vehicle Insurance Fund respectively and a levy of three thebe per litre payable in respect of the Equalization Fund,</p> <p style="margin-left: 20px;">(ii) in respect of diesel a levy of three thebe per litre payable in respect of the Equalization Fund,</p> <p style="margin-left: 20px;">(iii) in respect of diesel levies of three thebe and four thebe per litre payable in respect of the National Petroleum Fund and Motor Vehicle Insurance Fund respectively;</p> <p>(b) at any place specified in the first column of the said Schedule, illuminating paraffin for domestic use in quantities of a litre or less at a price proportionate to that specified in relation to that place in the third column of the said Schedule; or</p> <p>(c) at any place not specified in the first column of the Schedule, the petroleum product specified at the head of the —</p> <p style="margin-left: 20px;">(i) second column of the Schedule at a price exceeding by more than nine thebe,</p> | <p>Retail prices of petroleum products</p> |

(iii) fourth column of the Schedule at a price exceeding by more than nine thebe per litre the price at which the product was delivered to him.

(d) The levy in respect of the Motor Vehicle Insurance Fund specified at paragraph (a) (i) and (a) (iii) shall be deemed to have come into effect on the 1st January 1991.
