An Act to amend the University of Botswana Act.

Date of Commencement: 3rd May, 1991. ENACTED by the Parliament of Botswana.

- 1. This Act may be cited as the University of Botswana (Amendment) Short title Act, 1991.
- 2. The University of Botswana Act is hereby amended by substitut- Substitution of ing section 11 thereof with the following new section —

"Powers of University Council

(1) Subject to the provisions of this Act, the University Council shall have power to do or provide for any act or thing in relation to the University which it considers necessary or desirable in its capacity as the governing body.

(2) Without prejudice to the generality of the provisions of subsection (1), the University Council may, where it deems it necessary or desirable, prohibit the admission of any person as a student of the University, suspend or dismiss any student of the University, or order the closure of the University, and the Council shall exercise these powers notwithstanding the disciplinary powers conferred on the Vice-Chancellor by section 7."
