MEMORANDUM

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. Article 10 of the Customs Union Agreement requires corresponding provisions to be made (by consensus) in the laws of Botswana, Lesotho, Namibia, South Africa and Swaziland on the subject of Customs and Excise.

3. The major changes being enacted are to make new provision for calculating the value for excise duty purposes of motor vehicles manufactured in Botswana. Provision is also made to consolidate and clarify administrative procedures relating to payment of interest and to amend Schedule 1 to the Act.

4. The amendments have been promulgated in South Africa and, in terms of Article 10 of the Customs Union Agreement, it now behaves us to follow suit.

1. This Act may be cited as the Customs and Excise Duty (Amend- Short title ment) (No. 3) Act, 1991.

2. (1) Section 74 of the Customs and Excise Duty Act, hereinafter Amendment referred to as "the Act", is amended, in subsection (2), by substituting for Cap. 50:01 paragraph (a) thereof the following new paragraph -

"(a) (i) For the purpose of assessing the excise duty on any goods specified in Section A of Part 2 of Schedule No. 1, (other than goods specified in items 117.01.10 and 117.05 to 117.30), the value

thereof shall be the price paid or payable for such goods when sold for home consumption in the ordinary course of trade, in the usual trade packing, where applicable, to any buyers not deemed to be related as specified in section 72(2)(a), plus any non-rebated excise duty payable in terms of Section B of Part 2 of Schedule No. 1, but excluding the non-rebated excise duty payable in terms of Section A of Part 2 of Schedule No.1 on such goods.

(ii) For the purpose of assessing the excise duty on any goods specified in items 117.01.10 and 117.05 to 117.30 of Section A of Part 2 of Schedule No. 1, the value thereof shall be the price paid or payable for such goods when sold for home consumption in the ordinary course of trade to any buyers not deemed to be related as specified in section 72(2)(a), plus any non-rebated excise duty payable in terms of Section B of Part 2 of Schedule No. 1 on such goods.".

(2) Subject to the provisions of the Act, this section shall be deemed to have come into operation on the 1st. June 1991.

Replacement of section 111 3. The Act is amended by substituting for section 111 of the Act the following new section —

"Interest on outstanding amounts

t on 111. Notwithstanding anything to the contrary in any written law —

- (a) interest shall be payable, as from such date and for such period as the Director may determine, on any outstanding amount payable in terms of this Act, other than the outstanding amount of any penalty or forfeiture payable in terms of this Act;
- (b) the interest so payable shall be paid at the rate which the Director may prescribe by rule but which shall not exceed the rate of interest prescribed under the Prescribed Rate of Interest Act;
- (c) the Director may in his discretion and on such conditions as he may consider necessary
 - (i) remit any interest for which any person is liable by virtue of this section;
 - (ii) permit payment of any amount referred to in paragraph (a) by instalments of such amount and at such times as he may determine;
- (d) any such instalment paid shall be utilized by the Director to discharge any penalty, forfeiture, interest and duty and other amounts due, in that order;

(e) any such interest shall be calculated monthly, and a portion of a month shall be regarded as a full month; and

any such interest recovered shall be paid into the Consolidated Revenue Fund.".
