SECTION

- 1. Short title

An Act to authorize the payment out of the Consolidated Fund and the Development Fund of sums of money for the year ending 31st March, 1993.

Date of Assent: 31.3.92.

Date of Commencement: 1.4.92.

ENACTED by the Parliament of Botswana.

1. This Act may be cited as the Appropriation (1992/93) Act, 1992. Short title

2. The Ministry of Finance and Development Planning may issue a Expenditure warrant for the payment from the Consolidated Fund for the year ending from Consolidated 31st March, 1993, of the sum of P3 885 888 730 (three thousand eight Fund hundred and eighty five million, eight hundred and eighty eight thousand, seven hundred and thirty Pula).

3. The sum authorized by section 2 is appropriated to and shall be Appropriation applied for purposes of the Heads of Expenditure set out in the first and of sum second columns of the Schedule, in the amounts set out in the section 2 corresponding entries in the third column of the said Schedule.

4. The Minister of Finance and Development Planning may issue a Expenditure warrant for the payment from the Development Fund for the year ending from Development 31st March, 1993, of the sum of P1 416 267 000 (one thousand four Fund hundred and sixteen million two hundred and sixty seven thousand Pula).

5. The sum authorized by section 4 is appropriated and shall be Appropriation applied to meet the total amount of expenditure necessary for of sum development projects during the financial year ending 31st March, 1993. by section 4
