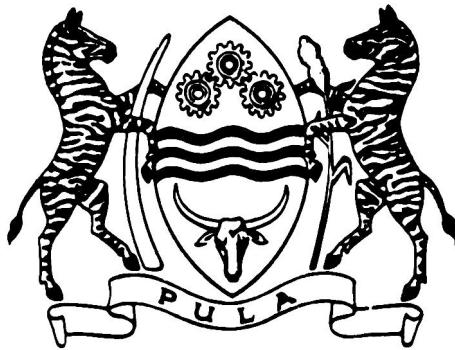

Government Notice No. 200 of 1993

CONSTITUTION OF BOTSWANA

Authorization to Exercise Functions of the Office of President

TO: THE HONOURABLE FESTUS GONTEBANYE MOGAE, M.P., VICE-PRESIDENT AND MINISTER OF FINANCE AND DEVELOPMENT PLANNING.

WHEREAS it is provided by section 36 (1) of the Constitution that whenever the President is absent from Botswana or considers it desirable so to do by reason of illness or any other cause he may, by directions in writing, authorize the Vice-President to discharge such of the functions of the office of President as he may specify, and the Vice-President may discharge those functions until the President's return to Botswana or the revocation of such authorization, as the case may be;

AND WHEREAS I intend to be absent from Botswana from the 27th June, 1993, and I consider it desirable to issue directions as aforesaid;

NOW THEREFORE, in exercise of the powers vested in me as aforesaid I authorize you, FESTUS GONTEBANYE MOGAE in your capacity as Vice-President and Minister of Finance and Development Planning, to discharge with effect from 27th June, 1993 all the functions of the Office of President, except —

- (a) the power to dissolve Parliament in accordance with the provisions of section 91 of the Constitution;
- (b) the power to appoint to the office of Minister or Assistant Minister in accordance with the provisions of section 42 of the Constitution;

Provided, however, that you can appoint the present Ministers or Assistant Ministers to act in place of any Minister who is otherwise not available;

- (c) the power to remove a Minister or Assistant Minister from office in accordance with the provisions of section 43 of the Constitution;

until my return to Botswana or this authority is revoked by me which ever happens first.

ELECTORAL (AMENDMENT) BILL, 1993

MEMORANDUM

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. One of the objects of this Bill is to re-introduce the provision relating to identity cards contained in the Electoral (Amendment) Act, 1988 (No.18 of 1988) which was subsequently repealed by the Electoral (Amendment) Act, 1989 (No.20 of 1989). To avoid personation at elections, it is proposed that the particulars required for nomination of candidates under section 32 of the Electoral Act to be in a nomination paper as prescribed by Form O in the Schedule shall include the identity cards, as enacted by the National Registration Act (Cap.01:02), of the candidate, his proposer, seconder and supporters. And also a person desiring to vote at an election shall, in addition to producing his voter's registration card to the presiding officer at the polling station as required by section 51 of the Electoral Act, produce his identity card. The proposal relating to identity cards has necessitated the amendment of sections 2, 30(1), 32, 34 and 51 of the Electoral Act.

3. It is also proposed to amend the Electoral Act to provide that the counting of votes at an election should be done at the polling stations immediately after the close of polls. The presiding officers shall be counting officers who shall be assisted by the polling staff. This proposal has also necessitated the amendment of sections 46, 47, 59, 65 to 73 and 75 of the Electoral Act.

4. The Bill also proposes to amend section 74 of the Electoral Act to provide that where there is an equality of votes between any candidates at the end of counting of votes at an election, a fresh election shall be held in that constituency.
