is amended -

(a) by the insertion immediately after the definition of the words "general roll" appearing therein, the following new definition, "identity card' means an identity card issued under the National Registration Act;"; and

(b) by the insertion immediately after the definition of the words "personal representative" appearing therein, the following new definition, "'police officer' has the meaning assigned to it by section 2 of the Police Act;".

3. Paragraph (a) of section 12 of the Act is amended by substituting for the words "sex and address" which appear therein, the words "sex, address and house number or plot number (where practicable)".
