

WATER ACT (CAP.34.01)

(CAP 34.01 SUB LEG)

Application for Water Rights

IN ACCORDANCE with the provisions of regulation 12 of the Water Regulations, notice is hereby given that the applications set out in the Schedule for the Grant of Water Right have been made to the Water Apportionment Board in respect of which the application is set forth:—

- (a) The name and address of the applicant

Special Criminal Court Session — 1st November 1993 — 15th December 1993

CURRENTLY THERE ARE 59 murder cases pending before the High Court in Lobatse, and 25 in the High Court in Francistown. These are cases where indictments have already been filled. It appears there is in the pipeline 25 murder cases to be indicted before the High Court in Francistown, and possibly another 50 cases to be indicted before the High Court in Lobatse.

In the circumstances therefore, the Chief Justice, after consultation with the other judges, has decided that there should be a special criminal court session to deal with these murder cases commencing from 1st November, 1993—15th December 1993, both dates inclusive.

In the High Court — Lobatse, one judge will be assigned to deal with civil matters and urgent applications. The other four judges would be exclusively assigned to deal with the pending murder cases.

In the High Court — Francistown, the 2 judges would with effect from 1st November 1993 — 15th December 1993, deal with the pending murder cases in their courts, but will alternate on Fridays to deal with civil matters.

It is hoped that with the co-operation of the Attorney-General's Chambers, the attorneys and the public, these cases might be concluded, or at least substantial number of the cases would have been concluded before the next legal year in February, 1994.

Tex (Pty) Ltd is prescribed as a business which may be granted additional tax relief for the purpose of its production of textile garments, including ladies and girls' blouses, pants, shorts and jackets and mens' shirts, primarily for export, being a business project of benefit for the development of the economy of Botswana.

Prescription

3. The business prescribed in paragraph 2 may be granted additional tax relief as set out hereunder —

Additional tax relief

- (a) for any of the twenty consecutive tax years commencing on 1st November, 1993, the total tax chargeable under both paragraphs (a) and (b) of item I of Part IV of the Tenth Schedule of the Act shall be at the rate of 15 per cent; and
- (b) the provisions of section 59(1) (a) and the Ninth Schedule of the Act shall not apply in respect of any dividend paid out of profits, after the deduction therefrom of the tax specified under paragraph (a) hereof, for the first ten years from the 1st November, 1993.

WATERWORKS ACT (Cap 34:03)

MAUN WATERWORKS AREAS ORDER, 1993

(Published on 27th August, 1993)

IN EXERCISE of the powers conferred on the Water Authority by section 17 of the Waterworks Act, the following Order is hereby made —

- This Order may be cited as the Maun Waterworks Areas Order, 1993.
 (a) The following activities are with immediate effect prohibited Prohibition
 - (i) new private connexions,
 - (ii) washing of vehicles by hose pipe,
 - (iii) any form of irrigation or watering of gardens, lawns etc.
 - iv) use of water for major construction activities.
 - (b) These measures will remain in force until further notice.
 - (c) The public is reminded that under all circumstances the following are prohibited
 - (i) collection and cartage of water in drums from public standpipes and private connexions.
 - (ii) watering of livestock from standpipes and private connexions.
- 3. Any person who contravenes paragraphs 2 (a) and 2 (c) of this Order shall be guilty of an offence and shall be liable to the penalties provided under section 26 of the Act.
