

# NATIONAL REGISTRATION (AMENDMENT) BILL, 1993

(Published on 26th November, 1993)

#### **MEMORANDUM**

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

The Bill seeks to amend the National Registration Act to remove constraints encountered during implementation of its provisions.

Section 3 of the Act is to be amended to enable the Registrar to delegate certain of his powers to public officers where pressure of work so requires or where there is a shortage of district registrars. It is further proposed that the requirement to register noncitizens is removed, since they can be identified by other documents, such as passports. This also entails other incidental amendments to remove several other references to non-citizens.

The present period of validity of national identity cards is 10 years. But since a child may have dual nationality until he reaches the age of 21 years, it is proposed that a Botswana identity card issued to a child having dual nationality shall not be valid after his 21st birthday, when he will have to decide whether or not he will retain his Botswana citizenship.

The proposed amendment of section 7 is intended to enhance the power of the Registrar to obtain information about applicants for registration from persons reasonably likely to have such information. The proposed amendment to section 20 also seeks to enable specified Departments to have access to information obtained under the Act.

"Functions of registrars

4. The Registrar shall keep or cause to be kept a national register of all citizens of Botswana of the age of 16 years or over, and district registers of all such citizens living within the districts concerned, and to whom identity cards have been issued."

- 6. (1) Subject to such regulations as may be made under this Act, every citizen of Botswana of or above the age of 16 years shall be qualified to be registered under this Act, and shall apply for registration to the Registrar or to the registrar of the area in which he ordinarily resides, within one month of his reaching the age of 16 years, or, if he becomes a citizen of Botswana after reaching the age of 16, within one month of so becoming a citizen.

- (2) An identity card shall be valid for a period of 10 years, and shall be renewable for further periods of 10 years each for so long as the holder of the card qualifies for registration under this Act:

Provided that where the applicant is under 21 years of age, and possesses dual citizenship in accordance with the Citizenship Act, his identity card shall be valid only until he reaches the age of 21 years, and will be renewed only if he then assumes Botswana citizenship.

(3) An identity card shall be renewed by the issue of a new card with an up-to-date photograph and with up-to-date particulars relating to the holder."

8. Section 11 of the Act is amended —

(6) Any person who, contrary to the provisions of this section, discloses information acquired by him in the exercise of his powers or the performance of his duties to, or permits access to information or records acquired under this Act by, unauthorized persons shall be guilty of an offence and liable to a fine of P1 000, in addition to any other disciplinary measures that may be taken against him by his employer."

# FIRE SERVICE BILL, 1993

(Published on 26th November, 1993)

#### **MEMORANDUM**

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

The purpose of the Bill is to replace the existing Fire Services Act, which proved to be too impracticable for the purposes of Botswana. The Bill provides for a Fire Service for Botswana, but divided into fire brigades to meet the needs of individual towns or cities, with personnel recruited by, and the responsibility of, the Unified Local Government Service. The Director of the Fire Service will be a public officer and will have overall control and direction of the various brigades.

This will help to ensure standardization of equipment (including fire engines and fire hydrants), uniforms, training and practices, and simplify promotions and transfers between fire brigades.

ENACTED by the Parliament of Botswana.

- Short title Interpretation
- 1. This Act may be cited as the Fire Service Act, 1993.
- 2. In this Act, unless the context otherwise requires —
- "Council" means a district council established under the Local Government (District Councils) Act, or a town or city council established under the Townships Act, as the case may be, and shall also include a township authority;
- "Council area" means the area for the administration of which a Council is responsible.

Establishment of Fire Service

- **3.** (1) There shall be a Fire Service for Botswana, which shall be part of the Unified Local Government Service, and shall be comprised of such fire brigades as shall be necessary or desirable for the prevention and control of fires in Botswana.
- (2) There shall be a Fire Service Director, hereinafter referred to as "the Director", who shall be a public officer and whose duties shall include the organization, co-ordination and regulation of fire brigades throughout Botswana.

Establishment of fire brigades

- 4. (1) When the Director is of the opinion that a fire brigade should be established in any Council area, he shall so advise the Council concerned and the Establishment Secretary, at the same time making such recommendations regarding the size of the brigade, its situation, the equipment required, the training to be provided, and any other matters that he considers relevant.
- (2) Upon receipt of the advice and recommendations of the Director, the Council concerned shall proceed to take whatever steps are necessary to provide a suitable site for a fire station, housing for personnel, whatever vehicles and equipment are necessary for the proper operation of the fire brigade, and to deal with any other matters required under this Act, or referred to or recommended by the Director, and the Establishment Secretary shall make the necessary appointments of personnel to constitute the fire brigade.
- (3) Promotions within the Fire Service, transfers between brigades, schemes of sevice and training, and conditions of service shall be made or determined by the Establishment Secretary, in consultation with the Director, and with the senior officer of the brigade concerned.

Provision of adequate water supplies

5. (1) Each Council shall be responsible for ensuring that adequate supplies of water are available and secured for use when required in case of fire, and for this purpose may enter into agreement with the relevant water authority appointed under the provisions of the Waterworks Act, and the water authority shall not unreasonably refuse to enter into such an agreement.

- (2) Any question as to whether a water authority has unreasonably refused to enter into such an agreement shall be determined by the Minister, after consultation with the Minister for the time being responsible for water affairs.
- (3) The relevant water authority shall, at the request of the Director, or of the senior officer of the fire brigade concerned, and in accordance with any regulations made under section 14
  - (a) fix fire hydrants, capable of providing adequate supplies of water, on its mains at such places as may be most effective or convenient for providing water necessary to extinguish fires within the Council area, and when necessary replacing such hydrants:

Provided that the fire brigade of the area concerned may carry out such regular standard tests of such hydrants as it considers necessary to ensure that they are maintained in good working order and capable of providing adequate supplies of water in case of fire;

- (b) cause such fire hydrants to be plainly indicated by notice or distinguishing sign placed adjacent thereto or on any wall or fence near by.
- (4) The cost of maintaining such hydrants shall be met by the Council concerned:

Provided that —

- (a) where an area is to be or is being developed, the cost of supplying and fixing fire hydrants shall be borne by the body responsible for the development; and
- (b) where any hydrant is damaged as the result of any use made of it, with or without the consent of the water authority, other than for fire-fighting purposes or for any other purpose of a fire brigade, the person responsible for such damage shall be liable for the cost of repairing or replacing the hydrant concerned.
- (5) Any person who uses a fire hydrant, other than for fire-fighting purposes or any other purpose of a fire brigade, or other than for any purpose authorized by a water authority or by any person to whom the hydrant belongs, and any person who damages or obstructs any fire hydrant otherwise than in consequence of its use for such an authorized purpose, or any person who makes an unauthorized connexion to a fire hydrant, shall be guilty of an offence and liable to a fine of P3 000 and to imprisonment for three years.
- (6) The Director may take whatever steps are necessary to ensure that water supplies and fire hydrants will be adequate to cope with any fire that may occur, that fire hydrants are strategically placed and that they and other fire fighting apparatus and equipment are standardised and suitable for the purpose.
  - (7) A Council may, on the advice of the Director, by agreement —
  - (a) secure the use, in case of fire, of water under the control of any person other than a water authority;

- (b) improve access to any such water; and
- (c) lay and maintain pipes and carry out other works in connexion with the use of such water in case of fire.
- (8) In case of any fire —
- (a) a fire brigade may use for fire-fighting purposes any convenient and suitable supply of water, but shall be liable to replace any water used, or to pay compensation therefor;
- (b) a water authority shall, on being required by the most senior fire brigade officer present to provide a greater supply and pressure of water for extinguishing a fire, take all necessary steps to comply with such requirement, and may for such purpose shut off water at the mains or in any pipes in any area; and no authority or person shall be liable to any penalty or claim by reason of any interruption of the supply of water occasioned by any compliance with such a requirement.

Notice of proposed works likely to affect water supply

- **6.** (1) Where any person proposes to carry out any works for the purpose of supplying water to any part of the area of a Council, he shall give notice in writing thereof to the fire brigade of the area concerned not less than four weeks before the works are begun.
- (2) At least seven days before any works are begun which affect or are likely to affect any fire hydrant, the person by whom such works are to be executed shall give written notice thereof to the fire brigade of the area in which hydrant is situated:

Provided that where, in an emergency, it is not practicable for notice to be given at the time required under the provisions of this subsection, it shall be sufficient if such notice is given at the earliest practicable opportunity.

- (3) Any person who contravenes or fails to comply with the provisions of this section shall be guilty of an offence and liable to a fine of P1 000 and to imprisonment for six months.
- 7. (1) Every fire officer shall be liable for duty at all times and may at any time be detailed for duty in any part of Botswana, as the Director may reasonably authorize or require.
- (2) It shall be the duty of every fire officer, at all times, to perform and carry out the duties entrusted to him, to the best of his ability, and at all times to comply with any general or specific orders applicable to him, or as may be issued by the Director or by the senior fire officer of the fire brigade to which the fire officer is attached.
- (3) It shall be the duty of every fire officer to do all in his power to protect persons and property in the event of fire.
- 8. (1) Any member of a fire brigade maintained in pursuance of the provisions of this Act, and any police officer, may, in the course of his duties, in the event of fire, enter and if necessary break into any place or premises in which a fire has or is reasonably believed to have broken out, or any place or premises which it is necessary to enter for the purpose

Duties of

Powers of fire officers and police officers in event of fire of extinguishing a fire or of protecting it from acts done for fire fighting purposes, without the consent of the owner or occupier thereof, and may do all such things as he may deem necessary for such purpose or for rescuing any person or property therein.

(2) At any fire, the most senior fire brigade officer present shall have the sole charge and control of all operations for extinguishing the fire, including fixing the positions of fire engines and apparatus, attaching hoses to any water pipes, or the use of any water supply, and directing water hoses to any particular place, premises, object or part thereof, whether itself burning or adjacent to the fire.

(3) The most senior police officer present at the fire, or in the absence of a police officer the most senior fire brigade officer present, may close to traffic any street, or may stop or regulate traffic in any street, whenever in his opinion it is necessary or desirable to do so for fire fighting purposes.

(4) Any person who wilfully interferes with or obstructs any member of a fire brigade or a police officer engaged in fire fighting operations shall be guilty of an offence and liable to a fine of P5 000 and to imprisonment for four years.

9. Notwithstanding the provisions of any other law, in the event of any fire or other emergency, a fire engine or other fire brigade vehicle may, whilst proceeding to, or in attendance at, a fire or other emergency, be permitted to —

Use of vehicles in case of fire or other emergency

- (a) sound any audible warning of approach whilst in traffic or in any built up area;
- (b) display red rotating or flashing lights;
- (c) exceed the prescribed speed limit for the area concerned;
- (d) proceed, with caution, in the wrong direction down any one-way street, if so required to facilitate the most rapid access to the location of such fire or emergency;
- (e) park in any area not specifically designated as a parking area, for the purpose of carrying out its duties in respect of the fire or emergency;
- (f) park, with the engine running, in the direction of, or against the normal flow of traffic:
- (g) traverse, with caution, vehicular control signals and signs, where the passage for the vehicle is clear, and other traffic will not be endangered;
- (h) park or proceed on sidewalks, pavements, open spaces, paving or forecourts, if necessary to gain access for fire fighting or rescue purposes;
- (i) require other road users to give right of way and not impede the passage of such vehicles; or
- (j) require unimpeded access to such area as may be necessary in all the circumstances for fire fighting or other emergency purposes.

Safety measures by fire brigades

- 10. (1) An authorized officer of a fire brigade shall, in the interests of fire prevention,
  - (a) obtain and compile information, by inspection and otherwise, with regard to the character of buildings and other property in the area of the fire brigade, the available water supplies, the means of access to such buildings or property, and any other local circumstances;
  - (b) when so requested, give advice in respect of any buildings or other property in the area of the fire brigade, for the purpose of fire prevention, restricting the spread of fires and providing means of escape in the event of fire.
- (2) An officer of a fire brigade, so authorized in writing by the senior officer of such brigade, may enter any premises at a reasonable hour for the purposes of carrying out any inspection as referred to in subsection (1)(a).

Exemption from liability for damage

11. No action shall lie in any court against any fire officer, or any police officer, or any person acting under the instructions of such fire officer or police officer, in respect of any damage caused in the exercise of any powers conferred or the performance of any duties imposed under the provisions of this Act, unless it is proved that such damage was caused mala fide.

False alarms

12. Any person who knowingly gives or causes to be given a false alarm to any fire brigade or any member of such a brigade shall be guilty of an offence and liable to a fine of P3 000 and to imprisonment for three years.

Enquiries and directions by Minister

- 13.(1) The Minister may hold, or cause to be held, a public inquiry into the manner in which any fire brigade is carrying out its duties or performing its functions under this Act, or into the circumstances of, or the steps taken to deal with, any particular fire or other emergency.
- (2) The Minister may give instructions, either generally or in a particular instance, as to the operations of fire brigades or of a particular fire brigade, in the interests of protecting persons and property in the event of fire.

Regulations

- 14. The Minister may make regulations for the better carrying out of the purposes and provisions of this Act, and without prejudice to the generality of the foregoing such regulations may provide for all or any of the following matters
  - (a) the creation of fire brigades:
  - (b) the ranks constituting fire brigades, the qualifications therefor, and the procedure for appointments thereto or promotion therein;
  - (c) regulating and standardizing uniforms to be worn by members of fire brigades, and badges or indications of rank;
  - (d) regulating hours and conditions of work, and the granting of leave;
  - (e) regulating and maintaining standards of discipline necessary for fire brigades;

- (f) regulating and maintaining standards of training for members of fire brigades;
- (g) the establishment and maintainance of a central training institution for members or applicants for membership of fire brigades, and local training centres;
- (h) the design, performance and standardization of equipment and fire hydrants;
- (i) co-operation between fire brigades in the event of one fire brigade being requested to assist another fire brigade in fighting a fire.
- 15. The Fire Services Act is hereby repealed.

IN EXERCISE of the powers conferred by section 30 of the Education Act, the Minister of Education hereby makes the following Regulations:—

### PART I — Preliminary

Citation and application

Interpretation

1. These Regulations may be cited as the Colleges of Education Regulations, 1993, and shall apply to both teacher training colleges and colleges of education, except as may be otherwise provided.

2. In these Regulations, unless the context otherwise requires — "admitted" means allocated to a class or a boarding and lodging area;

"Board of Affiliation" means the Primary Teacher Training Board of Affiliated Institutions of the University of Botswana or the Colleges of Education Board of Affiliated Institutions of the University of Botswana, as appropriate;

"college" means a teacher training college or a college of education, unless otherwise specified;

"college days" means the days during each college term on which students are required to attend instruction;

"enrolled" means being permitted to take up studies at a college;

"exclude" means being denied the right to stay in a boarding area, or being denied the right to attend instruction in any particular area;

"expel" means being required to terminate studies at a college and being excluded from the course in which the student is enrolled;

"guardian" means any parent or close relative, not being a minor, or any other similar person, who is willing to support the student both morally and financially during his studies, or where the student is a minor, means the student's legal guardian;

"hostel" means any part of a college used as lodgings by the students of that college;

"leave" means a period of time when a student is permitted temporarily to be absent from his studies or accommodation in a hostel;

"passed" means awarded a pass grade or better by an examining body recognized by the Ministry of Education;

"principal" means the principal of a college;

"suspend" means to be denied for a limited period the right to attend classes, to take exams or to stay in a boarding area;

"withdraw" means to terminate studies at a college.

#### PART II — Enrolment at Colleges and Admission to Hostels

Applications for enrolment at colleges

- 3. (1) Any application for the enrolment of a student at a college, or for the admission of a student to a hostel, shall be made by the applicant in writing to the principal of the college.
- (2) The applicant shall furnish the principal with such information and evidence as may be required for the consideration of the application.
- (3) Any application for re-enrolment at a college, or for re-admission to a hostel, by a student who has ceased to be so enrolled or admitted, as the case may be, shall be made by the student in writing to the principal, and if granted such re-enrolment or re-admission shall be subject to such conditions as the Permanent Secretary may generally, or in any specific case, direct.

- (4) Any person who, in his application, or for the purpose of procuring his enrolment at a college or his admission to a hostel, knowingly makes a false statement, oral or in writing, which is material to such application, shall be refused such enrolment or admission, or shall have such enrolment or admission cancelled, and shall be guilty of an offence and liable to a fine of P200.
- 4. (1) The principal shall consider every application for the enrolment or re-enrolment of a person at a college or for the admission or re-admission of a person to a hostel, as the case may be, and shall, subject to the provisions of these Regulations and of any other written law, and to any conditions which may be imposed by the Permanent Secretary, determine whether or not the person concerned shall be enrolled or re-enrolled, or admitted or re-admitted, as the case may be, and shall inform the applicant of his decision, in writing, as soon as is reasonably possible.

(2) No student may be enrolled, re-enrolled, admitted or re-admitted into a college or hostel unless or until he has been medically examined and certified fit by an approved medical practitioner.

- (3) No applicant shall be enrolled as a student of a college unless the principal of the college is satisfied that the applicant, is, or will be on the 1st January of his first anticipated academic year at the college, at least 18 years but not more than 35 years of age.
- 5. (1) An applicant shall not be enrolled at a college as student in the first year unless he satisfies the entrance qualifications as laid down by the Ministry of Education, and such further entry requirements as the Permanent Secretary may, generally or in any specific case, impose.

(2) Every applicant may be required to pass a common entrance examination and attend a personal interview before being enrolled.

- 6. (1) A person shall not be enrolled at a college unless a vacancy exists in the class he should enter if he were so enrolled, and a student shall not be admitted to a hostel unless a suitable vacancy for him exists in such hostel.
- (2) A person shall not be enrolled at a college or admitted to a hostel unless he is a citizen of Botswana, or has obtained special permission from the Permanent Secretary.
- (3) A student shall not be admitted to a hostel unless he attends or is enrolled to attend the college to which such hostel is attached, and every student enrolled in a college may be required to stay in such a hostel, unless the Permanent Secretary, at his discretion, permits him to attend classes as a day student.
- (4) A student shall not be deemed to be enrolled in a college before he has signed a bonding certificate, subject to such conditions as the Permanent Secretary may determine, and his guardian has agreed.
- (5) A person who has at any time been expelled from any college shall not be allowed to seek re-admission or admission to any other college without the prior permission of the Permanent Secretary.
- 7. (1) Any student who has been enrolled at a college or admitted to a hostel shall ensure that he presents himself at the college or hostel on the first day of the college term, or in the case of enrolment or admission during the course of the college term, on such day as the principal may specify.
- (2) Any student who does not report to the college at which he has been enrolled within the first ten college days of the term may be removed by the principal from the list of students to be enrolled in the college.

Determination of application

Continuation in classes

- 8. No student at a college shall be permitted to spend more than one year in the same class except with the approval of the Permanent Secretary, which approval shall only be granted for the following reasons
  - (a) the student has failed to pass an examination for students in that class, and such failure was due to the student's ill-health, unavoidable absence from the examination, or such other cause as the Permanent Secretary considers justifiable;
  - (b) the principal of the college is satisfied that if that student spends an additional year in the class no student in a lower class will be prevented from progressing to the class in question;
  - (c) the principal is satisfied that if the student is permitted to spend an additional period in the class in question he is likely to succeed in passing the examination for students in that class.

Transfers between colleges

- 9. (1) No student shall transfer from a college at which he enrolled to another college unless the principal of the colleges at which the student is enrolled is satisfied that there are reasonable grounds for the transfer and gives permission therefor.
- (2) Where a student is permitted to transfer from the colleges at which he is enrolled the principal thereof shall give to the student a letter of transfer, stating the grounds of the transfer and giving evidence of the progress and ability of the student, which letter shall be presented by the student to the principal of the college to which he is transferring, together with his application for enrolment.
- (3) A student who transfers from a college at which he is enrolled to another college without permission shall be liable to forfeit his place at both colleges unless the Permanent Secretary directs otherwise.
- 10. Notwithstanding anything contained in this Part, the Permanent Secretary may, subject to the approval of the Minister, give to the principal of a college such directions as he may consider necessary in respect of
  - (a) the enrolment at the college, or the admission to a class or hostel of particular students or a particular student; or
  - (b) the transfer between colleges or hostels of particular students or a particular student.

Fees

Special directions

Secretary

11. Fees may be charged for education at a college at such rate as may be prescribed by the Minister.

#### PART III — College Calendar and Syllabuses

Academic year

- 12. (1) The academic year in every college shall consist of year three college terms.
- (2) The Permanent Secretary shall prepare an annual college calendar to determine the period of college terms and the days during each college term on which students shall be required to attend college or instruction.
- (3) The college calendar prepared by the Permanent Secretary shall be so arranged as to ensure that the number of college days in the academic year to which it relates is at least 185 days.
- (4) The college calendar prepared in accordance with this regulation shall be observed at all colleges except to such extent as the Permanent Secretary, may, either generally or in any particular case, authorize, and no departure from the calendar shall be made except with the prior approval of the Permanent Secretary.

(5) There shall be no formal class teaching on any public holiday appointed by or under the Public Holiday Act, except to such extent as the Permanent Secretary may authorize.

13. (1) Every college shall provide instruction in such subjects as the Permanent Secretary shall, in consultation with the Board of Affiliation and the National Council for Teacher Education, specify for the purpose of this regulation, either generally or in respect of a particular college or group of colleges.

Curricula and syllabuses

(2) A college shall not provide instruction in a subject that has not been specified by the Permanent Secretary under subregulation (1) unless the Permanent Secretary has, in consultation with the Board of Affiliation and the National Council for Teacher Education, authorized the college to do so.

(3) The syllabus to be followed in respect of each subject in which instruction is provided by a college shall be a syllabus approved by the Permanent Secretary in consultation with the Board of Affiliation and the National Council for Teacher Education.

(4) The granting of the qualification as a teacher shall be by the Board of Affiliation.

# PART IV — Suspension, Expulsion and Withdrawal of Students

14. A student shall not be suspended, expelled, excluded or required to withdraw from any college or hostel except in accordance with the provisions of this Part.

Restriction on expulsion etc.

15. (1) Subject to the provisions of subregulation (3), the principal may suspend from attendance at a college —

Conditions of suspension or exclusion

- (a) any student whose conduct and behaviour is habitually or continually such as is likely, in the opinion of the principal, to endanger the maintenance of a proper standard of discipline or conduct in the college;
- (b) any student who has committed an act of a gravely reprehensible nature:
- (c) any student who fails to attend classes regularly without reasonable excuse; or
- (d) any student who incites, promotes or participates in any strike, boycott or other act of serious indiscipline which, in the opinion of the principal, is prejudicial to the maintenance of a proper standard of conduct in the college.
- (2) Subject to the provisions of subregulation (3), the principal may exclude from any hostel attached to the college any student whose presence thereat is, in his opinion, prejudicial to the maintenance of discipline in the hostel.
- (3) Where any student is suspended from attendance at a college or excluded from a hostel under this regulation, the principal shall
  - (a) inform the student, and if he is a minor his guardian, in writing of the complaint against him and of the action the principal has taken; and
  - (b) send a full report of the facts of the case and the action taken, and a copy of all the correspondence relating thereto, to the Permanent Secretary.

- (4) A student may be suspended in accordance with this regulation for a period of up to 30 college days without the prior consent of the Permanent Secretary, but a suspension shall not exceed 30 college days unless the approval of the Permanent Secretary has been received.
- (5) A student may be suspended under this regulation with a recommendation by the principal that he be expelled, but a student may only be expelled from a college when such expulsion is approved by the Permanent Secretary.

Right to make representations

- 16. (1) A student, or if he is a minor his guardian, shall be entitled to make representations to the Permanent Secretary if the student—
  - (a) has been excluded from a hostel;
  - (b) has been withdrawn from the college due to lack of academic ability, ill health or continued or frequent absence;
  - (c) has been suspended; or
  - (d) has been expelled.
- (2) Representations to the Permanent Secretary under subregulation (1) must be made, in writing, within 21 calendar days after the date when the decision taken against him, or when any further action taken by the Permanent Secretary, was communicated to the student, or, if the student is a minor, to his guardian.

Powers of the Permanent Secretary

Withdrawal from college

- 17. (1) After considering any representations made to him in accordance with the provisions of regulation 16, the Permanent Secretary may, subject to the approval of, and such directions as may be given by, the Minister
  - (a) confirm the decision giving rise to the representations;
  - (b) cancel the decision, in whole or in part; or
  - (c) amend the decision, or give such other directions as may appear just in the circumstances.
- (2) Any decision made or directions given by the Permanent Secretary in accordance with the provisions of subregulation (1), may be made or given subject to such conditions as the Permanent Secretary may determine, and if any such condition is not complied with to the satisfaction of the Permanent Secretary he may exercise any of the other powers conferred on him by subregulation (1) in relation to the matter in issue, as in his opinion appears just in the circumstances.
- (3) The exercise by the Permanent Secretary of the powers conferred on him by this section shall, subject to the Minister's approval or directions, be final.
- 18. (1) (a) Where a principal is satisfied that there are good grounds for requiring a student to withdraw from a college on account of his lack of academic ability, ill health or continued or frequent absence, he may make a recommendation to this effect to the Permanent Secretary.
- (b) The principal shall not require the student to withdraw from the college under this subregulation unless or until he is authorized by the Permanent Secretary to do so.
- (2) A student who has not attended classes at the college at which he is enrolled for as many as thirty consecutive college days, or a total of sixty days in any one academic year, shall be required to withdraw from such college unless the principal is satisfied that there are reasonable grounds for such non-attendance, or unless the Permanent Secretary otherwise directs.
- (3) Any student who has not attended classes at the college at which he is enrolled for two consecutive college days, by reason of any strike, boycott or any act of serious indiscipline, shall be deemed to be withdrawn forthwith from such college, unless the Permanent Secretary otherwise directs.

19. (1) If a student at a college discovers herself to be pregnant, she shall immediately inform the principal of the college of such pregnancy and as soon thereafter as possible produce to him a medical certificate from a registered medical practitioner giving his opinion as to the approximate date of delivery.

(2) If at any time a principal has reason to believe that a student at the college may be pregnant, he may require the student to produce a medical certificate from a registered medical practitioner certifying whether or not, in his opinion the student is pregnant, and if so the approximate date of delivery, and failing production of such medical certificate within seven days immediately after the requirement is made, the principal may presume that the student is pregnant and act accordingly.

(3) The principal shall, after consultation with the pregnant student or, if the student is a minor, her guardian, plan a pregnancy leave of not less than one year, taking into account the following factors in determining the starting date of the leave and the return date of the student back into college —

(a) the information obtained from any medical certificate produced;

(b) the general health of the student;

(c) the academic ability of the student;

- (d) any requirements for certification prescribed in regulations of the Board of Affiliation;
- (e) that pregnancy leave may not start less than 6 weeks before the expected date of delivery;
- (f) any reasonable request by the student or, if the student is a minor, by her guardian; and
- (g) any other factor deemed likely to have a substantial impact on the medical fitness or welfare of the student or expected child.
- (5) Notwithstanding anything contained in subregulations (1) to (4), the principal may at any time
  - (a) require the student to produce a certificate of medical fitness from a registered medical practitioner;
  - (b) reconsider the plan for pregnancy leave and, if necessary, take steps to amend it; or
  - (c) suspend the student from college, if the student or her guardian omits or fails to fulfil any of the requirements of this regulation.
- (6) The principal shall obtain approval of the plan from the student and her guardian, and the student shall be required to abide by the plan, and the student or, if the student is a minor, the guardian shall indemnify the Government against any liability arising out of the student's continued stay at the college during her pregnancy.

(7) Notwithstanding anything contained in this regulation, the principal shall not readmit a student to the college after completion of her pregnancy leave unless a vacancy exists in the class in which she would be re-admitted.

- (8) Any student who becomes pregnant for a second time and requires a second pregnancy leave whilst still enrolled at a college, may be granted such leave provided that it is taken or occurs not less than two years after the end of her first pregnancy leave, and that she has been able to progress to the next grade or year, but in any other case such student shall be withdrawn permanently from the college.
- (9) Any student whose pregnancy ceases whilst she is still enrolled at a college shall not be allowed to re-attend studies at the college or resume her stay in a hostel unless or until she has been certified fit by a registered medical practitioner.

Pregnancy of student

Taking of examinations

- 20. (1) A student shall not be permitted to sit for any examination at a college during any period when he or she is suspended or expelled from the college, or is on pregnancy leave in accordance with the provisions of regulation 19, unless the Permanent Secretary has authorized the taking of such examination.
- (2) A student who has not attended classes at the college at which he is enrolled for as many as thirty consecutive college days, or a total of sixty college days in any one academic year, shall not be permitted to sit for any examination during such year unless the Permanent Secretary directs otherwise.

Breaking of bond 21. A student who breaks his course of study without such cause as is, in the opinion of the Permanent Secretary, reasonable and acceptable, shall be required to refund to the Government, in terms of the conditions of his bond, such sum as may be determined by the Permanent Secretary, subject to the approval of the Minister.

# PART V — Safeguards for Health of Students

Health of students

- 22. (1) If a student, while present at a college, becomes ill or sustains an injury, and in the opinion of the principal such illness or injury is serious, the principal shall take every reasonable step to inform the student's guardian thereof as soon as possible.
- (2) If on admission to a college a student appears to be medically unfit, the principal may require that the student should produce a medical certificate of fitness issued by a registered medical practitioner within 7 days, failing which he may suspend the student from the college for such period as he may stipulate, or until the student produces such a certificate of fitness.
- (3) If a student is discovered to be suffering from an infectious or contagious disease, the principal may require that he withdraws from the college forthwith, and may be allowed to return only on production of a certificate issued by a registered medical practitioner certifying that the student is no longer suffering from an infectious or contagious disease.
- (4) If three or more cases of an infectious or contagious disease are found in a college at any one time, the principal shall report the fact as soon as possible to the Permanent Secretary and to a Government medical officer, who may take such action as the situation requires.
- (5) The principal may arrange for a student accommodated in a hostel who becomes ill, to be isolated during the period of his illness.
- (6) A student accommodated in a hostel shall not be permitted to remain ill in bed for more than 2 days without medical attention from a registered medical practitioner or nurse.
- (7) If a student accommodated in a hostel repeatedly refuses or avoids medical treatment, the principal shall as soon as possible report the matter to his guardian and the Permanent Secretary.
- (8) It shall be the responsibility of the principal of a college to ensure that any student accommodated at the college hostel who needs medical treatment receives it, at his own expense or that of his guardian, so long as that student remains under the control of the college.
- (9) If a student is not accommodated at a hostel, it shall be the responsibility of the student or his guardian to ensure that the student, when ill, receives appropriate medical attention.

(10) If a principal has reason to believe that a student is ill, and the college is not able, in the opinion of the principal, to provide reasonable or adequate care for him, the principal may require the guardian to withdraw the student from the hostel on leave, and the student's return to the hostel may be made conditional on his producing a medical certificate of fitness from a registered medical practitioner.

### PART VI - General

23. The number of teachers which should normally be employed in a college shall be determined by multiplying the number of classes in the college by a factor of 2,25.

Number of teachers

24. (1) All colleges shall be subject to supervision and inspection by inspectors from the Ministry of Education.

Inspection of colleges

- (2) A college shall be subject to a full scale self-study and related visit by an inspector at least once every three years, or as may more frequently be determined, in respect of any particular college, by the Permanent Secretary.
- (3) Such a full scale self-study by inspectors shall comprise or be in respect of
  - (a) the general and detailed organization and administration of the college by the principal, or whoever may be acting in his place;
  - (b) the organization and teaching of each subject throughout the college;
  - (c) the competence of each teacher in the college; and (d) the arrangement and composition of the curriculum.
- (4) The inspectors appointed by the Ministry of Education to inspect a college shall, after carrying out their inspection, prepare a detailed report thereon and shall submit it to the Permanent Secretary for his consideration, and such further action as he may deem necessary or desirable.

(5) The principal of the college inspected shall be given a copy of those parts of the inspector's report which, in the opinion of the Permanent Secretary, require the principal's attention.

25. (1) The principal of every college shall submit to the Permanent Secretary statistical returns and records in accordance with the provisions of this regulation.

Statistical returns

- (2) On or before the fifteenth college day of the first term in each year, the principal shall send by registered post to the Permanent Secretary the college enrolment form, giving the number of students, and a list of the teaching staff.
- (3) On or before the first college day in April of each year, the principal shall send by registered post to the Permanent Secretary the college annual return.
- (4) On or before the fifteenth day after the end of the second and third terms in each year, the principal shall send by registered post to the Permanent Secretary a terminal return.
- (5) All records and returns required in terms of this regulation shall be submitted on official forms which shall be drawn up and supplied to principals by the Permanent Secretary.
- (6) Every principal shall submit to the Permanent Secretary such other statistical information as he may, from time to time, require.

Responsibilities and duties of principals

- 26. Subject to the provisions of these Regulations, the principal of a college
- (a) be generally responsible for the development and good management of the college as an educational institution, and for all aspects of its organization, and, for the better discharge of such responsibilities, he shall have power to enforce the college rules by all reasonable means and to exercise control and supervision over other staff members;

(b) be responsible for the day to day administration of the college;

- (c) prepare a prospectus relating to the practical arrangements of the college for each academic year, setting out, inter alia, the dates on which the terms shall begin and end, the requirements from students in respect of any fees payable, and any other information which he considers necessary or desirable, which prospectus shall, after approval by the Permanent Secretary, be despatched to the persons or candidates selected for enrolment in the college;
- (d) compile and maintain a code of college rules on the subjects of hygiene, deportment, discipline and dress;
- (e) furnish each student or, if the student is a minor, his guardian with a copy of college rules before the student enters the college;
- (f) furnish each student or, if the student is a minor, his guardian, with a report on the progress of the student at least twice a year;
- (g) compile an annual report on the progress of the college at the end of each academic year and submit it to the Permanent Secretary;
- (h) call regular meetings of members of the college staff in order to discuss with them internal college affairs, and keep minutes of such meetings; and
- (i) be responsible for the day-to-day expenditure of the college, cause proper books of account to be kept of all monies received by him for the college, whether public monies or not, and furnish such financial information relating to the college as may be required by the Permanent Secretary; and
- (j) from time to time furnish the Permanent Secretary with information with regard to, and recommendations for the efficient running and development of, the college administration and programmes.
- 27. (1) Before students travel for the purpose of school sports, teaching practice or other extramural activity of students, by any form of road transport within Botswana, the principal shall ensure that the Government of Botswana is indemnified in respect of any loss and injury to such students or their luggage, and the principal shall take all reasonable precautions to ensure that the trip and transport is organized in a safe and satisfactory manner.
- (2) Before students travel in an organized group to a place outside Botswana, the principal shall obtain, where it is practicable to do so, the permission of the parents or of the guardians of such students and of the Permanent Secretary, at least thirty days before the expected date of departure of the group on the proposed journey or tour, and in so doing shall
  - (a) state the purpose of the journey or tour;
  - (b) indicate the mode of travel and places where the students will be accommodated:
  - (c) provide the Permanent Secretary with a list of names of all the students who will be travelling;

Transport and travel (d) submit the itinerary for the journey or tour;

(e) give the names of the teachers who will be accompanying the students on the journey or tour; and

(f) state the citizenship and passport number of each of the persons who

will be travelling.

(3) The principal shall ensure that before any journey outside Botswana is commenced, the students and any Government vehicle concerned are sufficiently insured against death, injury and material damage.

28. The Teacher Training Colleges Regulations are hereby revoked.

IN EXERCISE of the powers conferred by section 15 (1) of the Electricity Supply Act, and after consultation with the Botswana Power Corporation, the Minister of Mineral Resources and Water Affairs hereby makes the following Regulations —

#### PART I — Preliminary

Citation

1. These Regulations may be cited as the Electricity Supply (Licensing) Regulations, 1993.

Interpretation

2. In these Regulations, unless the context otherwise requires —

"consumer" means any person supplied with energy from an undertaking;

"consumer's installation" means any wiring installed by a consumer, together with any apparatus upon the premises connected or intended to be connected thereto;

"distributing main" means the portion of any main from which service lines originate for the purpose of general supply;

"energy" means electrical energy;

"main" means any electrical line through which energy may be supplied by an

undertaking for the purpose of general supply;

"service line" means any underground or overhead electric line through which energy may be supplied or is intended to be supplied by an undertaking to a consumer either from any main, or directly from the premises of such undertaking;

"supply terminal" means the end of any electrical line situated upon any consumer's premises at which the supply of energy is delivered from the service line;

"undertaking" means any undertaking for the generation or for the supply of energy within a defined area, with all the assets and liabilities appertaining thereto, whether or not carried on under the authority of a licence;

"works" includes electric lines, buildings, machinery, engines, or any matters or things of whatever description required to supply energy and to carry into effect the object of an undertaking.

3. These Regulations shall apply to all undertakings for the generation or supply of electrical energy, other than such undertakings as are not required to be licensed in accordance with the provisions of section 3 (2) of the Act.

Application of Regulations

# PART II — Licences for Generation or Supply of Electricity

4. Every application for a licence shall be made to the Minister in writing, in the form prescribed in the First Schedule, and giving such further information as the Minister may require.

5. (1) A licence granted by the Minister shall be in such form as he may determine, and shall bear the name of the applicant, the situation of his head office and a description of the undertaking to be carried on by him.

(2) A licence shall be granted for such period of time and subject to such conditions and restrictions as the Minister may determine, and as shall be stipulated in the licence.

(3) A licence shall not be ceded or transferred in any way to any other person without the prior written consent of the Minister.

(4) A licensee shall not use his licence in respect of any undertaking which is not specifically described in his licence.

(5) A licensee shall not supply energy outside the area of supply specified in his licence.

(6) A licensee shall commence to supply energy within the period specified in his licence, which period shall give due regard to the time required for the design and construction of the required works and the demand by the public for a supply of energy in the area in question.

(7) Any licence may, at the Minister's discretion, prescribe the maximum or minimum generating capacity of the plant which may be installed at any particular generating station or within any particular area.

(8) A licensee may, at the discretion of the Minister, be required to publish in the Gazette, at his own expense, details of the terms and conditions of his licence.

**6.** (1) Charges made by a licensee for the supply of energy to consumers shall be those specified in the licence or as may be agreed by the Minister, with due regard to the following circumstances —

(a) the capital and recurrent expenditure of the licensee in furnishing the supply;

(b) the amount of energy consumed;

(c) the uniformity or regularity of demand;

(d) the time when or during which the energy is required; and

(e) any special circumstances which may exist.

Application for licence

Form and conditions of licence

Charges for supply of electricity by licensees (2) An agreement between a licensee and any consumer, whereby any charge to that consumer will be changed from the price specified in the licence or as previously agreed by the Minister, shall not be valid unless or until the proposed change has been approved by the Minister.

Charges for connexion to main

- 7. (1) Charges made by a licensee for connecting a consumer's installation to his distributing main shall not exceed the capital cost of connecting up the service line and other apparatus to the supply terminals.
- (2) Where it is necessary for a licensee to extend or increase the capacity of his distributing main to permit the connexion of new consumers, or to meet the increase in demand of consumers, he may require the consumers or developers of the area to make a capital contribution towards the cost of so doing.

Alteration of or addition to licence

8. A licensee desiring any addition to or amendment of his licence or of the conditions or restrictions subject to which it is issued, shall make a written application therefor to the Minister, and if such addition or amendment is not inconsistent with the provisions of the Act or of regulations made under the Act, the Minister may, at his discretion, approve such addition or amendment, and amend the licence accordingly.

Cancellation of licence

- 9. The Minister may, at any time, in the public interest, cancel a licence, if
  - (a) having committed a breach of any of the conditions or restrictions of his licence, or of the provisions of the Factories Act, and after having received written notice of such breach from the Minister, fails, within a period of one month from the date of such notice, to take appropriate remedial action:
  - (b) fails to satisfy the Minister within a period to be stated in the licence, that he is able to discharge efficiently in all respects the obligations imposed by the licence; or
  - (c) consents to such cancellation.

Offences and penalties

10. Any person who contravenes any provision of these Regulations shall be guilty of an offence and shall be liable to a fine of P200 and to imprisonment for six months; and in the case of a continuing offence shall be liable to an additional fine of P100 and imprisonment for three months for each day on which the offence continues, and to have his licence cancelled by the Minister.

Annual returns

- 11. A licensee shall each year, within a period of six months after the end of the financial year during which he operates, or on such other date as may be agreed, submit to the Minister
  - (a) an audited revenue and expenditure account; and
  - (b) a statistical return, for the first year of operation as prescribed in the Second Schedule, and for each succeeding year as prescribed in the Third Schedule.
