#### CONSTITUTION OF BOTSWANA

#### Authorization to Exercise Functions of the Office of President

TO: THE HONOURABLE FESTUS GONTEBANYE MOGAE, M.P., VICE-PRESIDENT AND MINISTER OF FINANCE AND DEVELOPMENT PLANNING.

WHEREAS it is provided by section 36 (1) of the Constitution that whenever the President is absent from Botswana or considers it desirable so to do by reason of illness or any other cause he may, by directions in writing, authorize the Vice-President to discharge such of the functions of the office of President as he may specify and the Vice-President may discharge those functions until the President's return to Botswana or the revocation of such authorization, as the case may be;

AND WHEREAS I intend to be absent from Botswana from the 28th November, 1993 and I consider it desirable to issue directions as aforesaid:

NOW THEREFORE, in exercise of the powers vested in me as aforesaid I authorize you, FESTUS GONTEBANYE MOGAE in your capacity as Vice-President and Minister of Finance and Development Planning, to discharge with effect from 28th November, 1993 all the functions of the Office of President, except —

- (a) the power to dissolve Parliament in accordance with the provisions of section 91 of the Constitution;
- (b) the power to appoint to the office of Minister or Assistant Minister in accordance with the provisions of section 42 of the Constitution:

Provided, however, that you can appoint the present Ministers or Assistant Ministers to act in place of any Minister who is otherwise not available;

 (c) the power to remove a Minister or Assistant Minister from office in accordance with the provisions of section 43 of the Constitution;

until my return to Botswana or this authority is revoked by me, which ever happens first.

# INCOME TAX ACT (Cap. 52:01)

## DEVELOPMENT APPROVAL (BACKPACKER PRODUCTIONS (BOTSWANA)(PTY) LTD) ORDER, 1993

(Published on 10th December, 1993)

IN EXERCISE of the powers conferred by section 53 of the Income Tax Act, the Vice-President and Minister of Finance and Development Planning hereby makes the following Order —

1. This Order may be cited as the Development Approval (Backpacker Productions (Botswana) (Pty) Ltd) Order, 1993, and shall, subject to the provisions of section 53 of the Act, come into operation on the 1st January, 1994, for a period of twenty consecutive tax years.

Citation and duration

2. Backpacker Productions (Pty) Ltd is prescribed as a business which may be granted additional tax relief for the purpose of its production of camping equipment, including rucksacks, tents, sleeping bags and allied products, primarily for export, being a business project of benefit to the development of the economy of Botswana.

- (a) for any of the twenty consecutive tax years commencing on 1st July, 1994, the total tax chargeable under both paragraphs (a) and (b) of item I of Part IV of the Tenth Schedule of the Act shall be at the rate of 15 per cent; and
- (b) the provisions of section 59(1) (a) and the Ninth Schedule of the Act shall not apply in respect of any dividend paid out of profits, after the deduction therefrom of the tax specified under paragraph (a) hereof, for the first ten years from the 1st January, 1994.

## DEVELOPMENT APPROVAL (MONITOR KAMAZ TRUCKS (PTY) LTD) ORDER, 1993

(Published on 10th December, 1993)

IN EXERCISE of the powers conferred by section 53 of the Income Tax Act, the Vice-President and Minister of Finance and Development Planning hereby makes the following Order —

Citation and duration 1. This Order may be cited as the Development Approval (Monitor Kamaz Trucks (Pty) Ltd) Order, 1993.

Prescription

2. Monitor Kamaz Trucks (Pty) Ltd is prescribed as a business which may be granted additional tax relief for the purpose of its production of commercial trucks, being a business project of benefit to the development of the economy of Botswana.

Additional tax relief

- 3. The business prescribed in paragraph 2 may be granted additional tax relief as set out hereunder
  - (a) from the beginning of the third tax year following the tax year in which commercial production of trucks commences, there shall be a five year tax holiday;
  - (b) any assessed loss occurring in any of the first two tax years, inclusive of the tax year in which commercial production of trucks commences, shall be deductible in assessing chargeable income as provided in section 46 of the Income Tax Act; and
  - (c) any claims for the deduction, in ascertaining business chargeable income, of any allowance due under Parts I and II of the Third Schedule of the Income Tax Act for any of the ten consecutive tax years from and inclusive of the tax year in which commercial production of the trucks commences, may be made in any of the three tax years immediately succeeding the fifth and last tax year for which the tax holiday referred to in subparagraph (a) applies.
