

**CUSTOMS AND EXCISE DUTY (AMENDMENT) (NO. 2) BILL, 1993**  
*(Published on 17th December, 1993)*

**MEMORANDUM**

A draft of the above Bill, which it is intended to present to the National Assembly, is set out below.

The object of the Bill is to bring into line the Customs and Excise Duty legislation in Botswana with that of the Republic of South Africa as required in terms of Article 10 of the Customs Union Agreement.

The Bill amends section 2 of the Act by defining, in that section, the terms "dumping" and "subsidized export" in respect of which anti-dumping and countervailing duties, which are provided for under sections 59 and 60 of the Act respectively, are payable. The term "disruptive competition" is also defined and a new duty, namely a safeguard duty, will now be payable in respect thereof. The Bill further amends sections 47, 50, 58, 59, 60, 61, 81 and 90, as well as the heading to Part VI of Cap. 50 : 01 by making provision for the new safeguard duty within those sections.

By clause 6, the Bill repeals section 51A of the Act which was erroneously inserted in the Act by the Customs and Excise Duty (Amendment) Act, 1989 (No. 8 of 1989).

Finally, section 53 of the Act is amended by clause 7 of the Bill in order to correct certain anomalies created when the Act was amended earlier.

“ subsidized export” means the export or the proposed export of goods to Botswana from any country where the authority of that country or any other country provides any form of financial aid or other assistance in respect of those goods, including assistance in respect of the production, manufacture, transport or export thereof;”.
