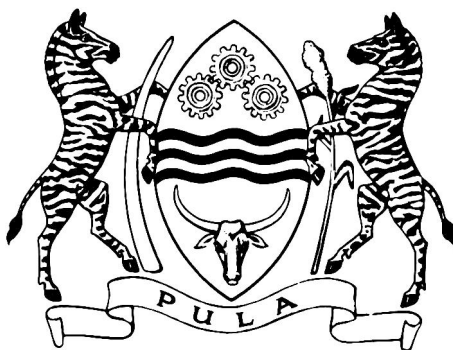

CONSTITUTION OF BOTSWANA

Authorization to Exercise Functions of the Office of President

TO: THE HONOURABLE FESTUS GONTEBANYE MOGAE, M.P., VICE-PRESIDENT AND MINISTER OF FINANCE AND DEVELOPMENT PLANNING.

WHEREAS it is provided by section 36 (1) of the Constitution that whenever the President is absent from Botswana or considers it desirable so to do by reason of illness or any other cause he may, by directions in writing, authorize the Vice-President to discharge such of the functions of the office of President as he may specify, and the Vice-President may discharge those functions until the President's return to Botswana or the revocation of such authorization, as the case may be;

AND WHEREAS I intend to be absent from Botswana from the 14th February, 1995 and I consider it desirable to issue directions as aforesaid;

NOW THEREFORE, in exercise of the powers vested in me as aforesaid I authorize you, FESTUS GONTEBANYE MOGAE in your capacity as Vice-President and Minister of Finance and Development Planning, to discharge with effect from 14th February, 1995 all the functions of the Office of President, except —

- (a) the power to dissolve Parliament in accordance with the provisions of section 91 of the Constitution;
- (b) the power to appoint to the office of Minister or Assistant Minister in accordance with the provisions of section 42 of the Constitution:
Provided, however, that you can appoint the present Ministers or Assistant Ministers to act in place of any Minister who is otherwise not available;
- (c) the power to remove a Minister or Assistant Minister from office in accordance with the provisions of section 43 of the Constitution,

until my return to Botswana or this authority is revoked by me which ever happens first.

SCHEDULE

IN EXERCISE of the powers conferred by section 16 of the Civil Aviation Act, the Minister of Works, Transport and Communications hereby makes the following Regulations —

1. These Regulations may be cited as the Civil Aviation (Fees) Regulations, 1995, and shall come into operation on such date or dates as the Minister may, by notice in the Gazette, appoint. Citation and commencement
2. In these Regulations, unless the context otherwise requires, "weight" means the maximum total weight authorized for the aircraft in its certificate of airworthiness or the associated flight manual. Interpretation
3. In respect of a certificate of registration, or a duplicate thereof, issued under regulation 4 of the Air Navigation Regulations, hereinafter referred to as "the Regulations", fees shall be payable as provided in Part 1 of the Schedule hereto. Fees for certificates of registration and duplicates
4. (1). In respect of the grant of an air operator's certificate in accordance with regulation 6 of the Regulations, and such other matters as are referred to in Part 2 of the Schedule hereto, fees shall be payable as therein provided. Fees for air operator's certificate (AOC)
(2) No part of any fee which has been paid in accordance with this regulation shall, by reason of any amendment to the certificate in question, be refunded after the certificate has been granted.

5. In respect of the issue of a certificate of airworthiness, or a renewal or a validation thereof, in accordance with regulation 8 of the Regulations, and for such other matters as are referred to in Part 3 of the Schedule hereto, fees shall be payable as therein provided.

6. In respect of the issue of a licence to act as an aircraft maintenance engineer, or a certificate of validation thereof, in accordance with regulation 12 of the Regulations, and for matters in connexion therewith, fees shall be payable as provided in Part 4 of the Schedule hereto.

In respect of the issue of a flight crew licence issued in accordance with regulation 20 of the Regulations, or a certificate of validation thereof in accordance with regulation 21 of the Regulations, or for matters connected therewith, fees shall be payable as provided in Part 5 of the Schedule hereto.

8. In respect of the issue of a licence to act as an air traffic controller or as a student air traffic controller in accordance with regulation 61 of the Regulations, or for matters connected therewith, fees shall be payable as provided in Part 6 of the Schedule hereto.

9. (1) In respect of the registration and licensing of aerodromes and of annual renewals thereof, fees shall be payable as provided in Part 7 of the Schedule hereto.

(2) Any costs involved in providing transport for the purpose of inspecting aerodromes in connexion with their registration or licensing shall be borne by the owners of such aerodromes.

10. In respect of the grant of a non-scheduled international air service permit in accordance with the provisions of the Air Transport (Temporary Air Service Permits) Regulations, fees shall be payable as provided in Part 8 of the Schedule hereto.

11. In respect of landings at aerodromes in Botswana, and in accordance with the provisions of regulation 71 of the Regulations, fees shall be payable as provided in Part 9 of the Schedule hereto.

12. In respect of the approval given by the Director to a maintenance organization, in accordance with regulation 9 of the Regulations, fees shall be payable as provided in Part 10 of the Schedule hereto.

13. In respect of the issue, renewal, or variation of a licence in accordance with the Air Transport (Licensing of Air Services) Regulations, 1955, or any amendment thereof, to operate air services into, or from, or within Botswana for the transportation of passengers or freight for hire and reward, fees shall be payable as provided in Part 11 of the Schedule hereto.

Parking fees

14. (1) In respect of parking at aerodromes in Botswana, fees shall be payable as provided in Part 12 of the Schedule hereto.

(2) Operators or pilots of aircraft must ensure that parking fees are paid promptly, and where no Government staff is available at the aerodrome parking fees may be remitted by cash or cheque to the Director of Civil Aviation in Gaborone within 48 hours after departure of the aircraft from the aerodrome.

(3) Any pilot or operator who fails to comply with the provisions of this regulation shall be guilty of an offence and liable to the penalties prescribed in regulation 83 of the Regulations.

15. An operator requesting services or inspection from the Department of Civil Aviation at any place outside Botswana shall bear the expenses of the Department in connexion therewith, in addition to the payment of all other relevant charges.

16. (1) In respect of every departing passenger, both international and domestic, a passenger service charge shall be payable as provided in Part 13 of the Schedule hereto, which charge shall be collected by the carrier or operator at the point of sale of the relevant flight ticket.

(2) In the case of scheduled air services the airline shall include the charge in the cost of the airline ticket, and in the case of chartered or private flights the charterer or the private operator concerned shall be responsible for the collection and payment of the full amount, which shall be the equivalent of the charge multiplied by the number of passengers on board, excluding the crew.

(3) The Department of Civil Aviation shall invoice the carrier or operator, on a monthly basis, for the full amount due.

17. (1) Where the Director is satisfied that any fee payable under these Regulations would, apart from this regulation, be payable by the Government, and that such fee is not in connexion with aerial work or public transport as defined in the Regulations, he shall exempt the Government from payment of that fee.

(2) In any case where he considers it to be in the public interest to do so, the Director may, on application being made to him for that purpose, exempt any person from payment of any fee that would otherwise be payable in accordance with these Regulations.
