



ARRANGEMENT OF SECTIONS

**SECTION**

1. Short title
2. Authorization to raise loan
3. Loan to be paid into Development Fund
4. Loan to be charged upon Consolidated Fund
5. Powers of Minister in connexion with loan

**An Act to authorize the raising by Government of a loan from the Overseas Economic Cooperation Fund for the purpose of assisting in the financing of the North-South Carrier Water Project.**

*Date of Assent:* 8.12.95.

*Date of Commencement:* 11.12.95.

ENACTED by the Parliament of Botswana.

1. This Act may be cited as the North-South Carrier Water Project Loan (Authorization) (Overseas Economic Cooperation Fund) Act, 1995.

Short title

2. The Minister of Finance and Development Planning may raise by loan from the Overseas Economic Cooperation Fund sums not exceeding, in the aggregate 4,685,000,000 Japanese Yen or the equivalent of 129,000 000 Pula, on such terms as may be agreed between the Minister and the Fund for the purpose of financing the North-South Carrier Water Project.

3. The proceeds of the loan authorized to be raised by this Act shall be paid into the Development Fund.

4. All sums required to repay the loan and to pay any other charges thereon shall be charged upon and paid out of the Consolidated Fund.

5. The Minister is hereby empowered to sign, on behalf of the Government, and to authorize any public officer so to sign, any agreements embodying the terms and conditions of the loan, and to do all such things as may be necessary and expedient to effect or facilitate the loan or such agreements.

PASSED by the National Assembly this 7th day of December, 1995.
