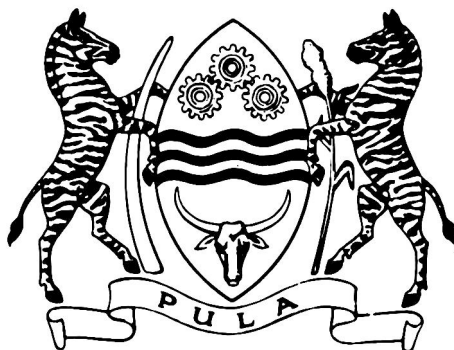

(1) Where a teacher is convicted of a criminal offence and is sentenced to imprisonment, whether such imprisonment takes immediate effect or is delayed pending an appeal, he shall receive no emoluments from the date of such conviction, pending a decision by the Director as to whether any emoluments shall be paid to him during the period of imprisonment and pending the taking of any disciplinary proceedings against him.

(2) Where a teacher is convicted of a criminal offence and is sentenced to a fine or a fine and imprisonment in lieu, and is sent to prison at that time or subsequently for the non-payment of the fine, he shall receive no emoluments from the date of such imprisonment, pending a decision by the Director as to whether any emoluments shall be paid to him during the period of imprisonment and pending the taking of disciplinary proceedings against him.

(3) Where a teacher is convicted of a criminal offence and is sent to prison in any of the circumstances referred to in subsections (1) and (2), the Director may, upon production of a certified copy of the criminal proceedings and of the warrant of committal to prison, dismiss the teacher without instituting disciplinary proceedings against him.

(4) If the teacher appeals against such conviction, his emoluments shall continue to be withheld pending the outcome of the appeal, but if the appeal is successful and the sentence of imprisonment is set aside, he shall, if his services have been terminated, be reinstated with effect from the date of termination, and he shall have repaid any emoluments withheld:

Provided that such setting aside shall not be a bar to disciplinary proceedings being instituted against such teacher arising out of the same facts, but in respect of a different offence under the laws or administrative orders governing the conduct of teachers, if those facts disclose such different offence.”.

9. Section 27(2) of the Act is amended by inserting immediately after the words "public officer" the words "from the Teaching Service".

**CENTRE FOR ACCOUNTING STUDIES SPECIAL FUND  
(AMENDMENT) ORDER, 1996**

IN EXERCISE of the powers conferred on the Minister of Finance and Development Planning by section 25 of the Finance and Audit Act the following Order is hereby made —

Citation

1. This Order may be cited as the Centre for Accounting Studies Special Fund (Amendment) Order, 1996, and shall be deemed to have come into operation on 13th July, 1990.

2. The Centre for Accounting Studies Special Fund Order is hereby amended by adding at the end of paragraph 9 thereof, the following new paragraphs —

“Board of  
Management

10. (1) There is hereby established a Board of Management of the Fund (in this order referred to as ‘the Board’).

(2) The Board shall consist of a chairman and seven other persons appointed in writing by the accounting officer.

(3) The Board shall be responsible for:—

- (a) the formulation of the general policy for the administration and management of the Centre;
- (b) promoting the harmonisation of accountancy education and training in Botswana;
- (c) promoting research and the advancement of the development of professional education programmes in accountancy, financial management, taxation and allied subjects;
- (d) supporting the development, production and dissemination of relevant teaching materials;
- (e) participating in accountancy educational initiatives in the SADC region and elsewhere.

11. (1) The accounting officer shall appoint the Director and senior members of the staff of the Centre on such terms and conditions as it may determine.

(2) The Director shall be responsible, subject to the control and direction of the Board, for the day to day administration and management of the Centre.

(3) The Director shall appoint the junior members of the staff of the Centre, and shall perform such functions of the Board as may be delegated to him.”
