SECTION

- 1. Short title

An Act to authorize the raising by Government of a loan from the Nordic Investment Bank for the purpose of assisting in the financing of the North-South Carrier Water Project.

Date of Assent: 04.04.96.

Date of Commencement: 09.04.96.

ENACTED by the Parliament of Botswana

1. This Act may be cited as the North-South Carrier Water Project St. Loan (Authorization)(Nordic Investment Bank) Act, 1996.

2. The Minister of Finance and Development Planning may raise by loan from the Nordic Investment Bank sums not exceeding, in the aggregate, 14 million US Dollars or the equivalent of 40 million Pula, on such terms as may be agreed between the Minister and the Bank for the purpose of financing the North-South Carrier Water Project.

3. The proceeds of the loan authorized to be raised by this Act shall be paid into the Development Fund.

4. All sums required to repay the loan and to pay any other charges thereon shall be charged upon and paid out of the Consolidated Fund.
