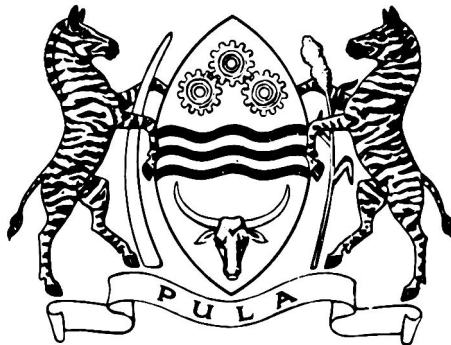

Income Tax Returns — Tax Year ending 30th June, 1996

IN ACCORDANCE with section 64 (2) of the Income Tax Act, notice is hereby given that every person shall furnish a tax return in the prescribed form for the tax year ending 30th June, 1996 within 2 months after the end of tax year.
