## COMPANIES ACT (Cap. 42:01)

## COMPANIES (AMENDMENT OF SEVENTH SCHEDULE) ORDER, 1996

(Published on 5th July, 1996)

IN EXERCISE of the powers conferred on the Minister by section 314(1)(a) of the Companies Act, the following Order is hereby made —
