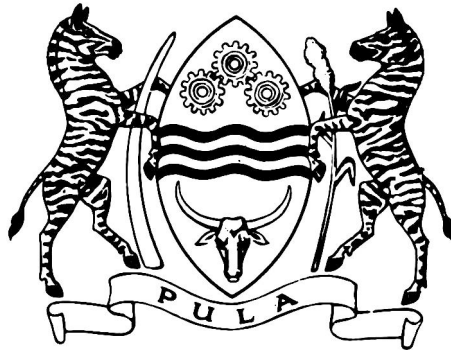

DEEDS REGISTRY (AMENDMENT) BILL, 1996

(Published on 20th September, 1996)

MEMORANDUM

A draft of the above Bill, which it is intended to present to the National Assembly, is set out below.

Section 18 of the Deeds Registry Act (Cap. 33 : 02), provides, amongst other things, that unless the marital power has been excluded, or unless the Registrar of Deeds deems the assistance of her husband unnecessary on other grounds, a woman married out of community of property must be assisted by her husband in executing any deed or other document required or permitted to be registered in the deeds registry, or required or permitted to be produced in connection with any such deed or document.

No immovable property can be transferred or ceded to a woman married in community of property except where the property has been excluded from community and the marital power by law or by a condition of a bequest or donation.

The principal object of the Bill is to enable women, whether married in or out of community, and whether or not the marital power has been excluded, to execute deeds and other documents required or permitted to be registered in the deeds registry without their husband's assistance.

Clause 2 of the Bill amends various subsections of section 18 of the Act. Firstly, subsection (3) is amended to make it possible for immovable property to be transferred or ceded to women as if they were married out of community and the marital power did not apply. The proviso to subsection (4) has been deleted while the main part of the subsection is restated to make it clear that any immovable property bequeathed or donated to a woman married in community of property may be transferred or ceded to her if it has, by a condition of the bequest or donation, been excluded from the community and the marital power. Subsection (5) is amended to remedy the present situation whereby a husband married in community of property may, unless his wife has been authorised by an order of court to deal therewith, alone deal with immovable property which is not excluded from community and has been registered in the name of his wife. Finally, the section is amended by deleting, from subsection (7) thereof, the reference to assistance by a woman's husband.

“(3) A woman whether married in community of property or not shall not require the assistance of her husband in executing any deed or document required or permitted to be registered in the deeds registry or required or permitted to be produced in connection with any such deed or document, and immovable property may be transferred or ceded to her as if she were married out of community of property and the marital power did not apply.”;

(b) by substituting, for subsection (4) thereof, the following new subsection —

“(4) Immovable property bequeathed or donated to a woman married in community of property may be transferred or ceded to that woman and shall not form part of the joint estate where, by a condition of the bequest or donation it is excluded from the community and the marital power.”;

(c) by substituting, for subsection (5) thereof, the following new subsection —

“(5) If immovable property not excluded from the community is registered in the name of a spouse married in community of property, neither spouse may, irrespective of when that property was so registered, alone deal with such property unless he has the consent, in writing, of the other spouse, or has been authorised by an order of court to deal therewith.”; and

(d) by deleting, from subsection (7) thereof, the words “(assisted where necessary by her husband)” which appear therein.

IN EXERCISE of the powers conferred on him by section 3 of the Control of Goods, Prices and Other Charges Act, the Minister of Commerce and Industry hereby makes the following Regulations —

1. These Regulations may be cited as the Control of Goods, Prices and Other Charges (Petroleum Prices) Regulations, 1996, and shall be deemed to have come into operation on 1st September, 1996.

2. In these Regulations "levy" has the same meaning as in the Control of Goods (Petroleum Products)(Levy) Regulations.

Interpretation

3. No person shall sell by retail, either in person or through an agent or employee —

Retail prices
of petroleum
products

(a) at any place specified in the first column of the Schedule hereto, the petroleum products specified at the head of the second, third, fourth or fifth column of the said Schedule, at a price exceeding the amount per litre specified in relation to that place in that column, which amount shall include —

(i) in respect of petrol, levies of 0,5 and 8 thebe per litre respectively, payable in respect of the National Petroleum Fund and the Motor Vehicle Insurance Fund, and a levy of 3 thebe per litre in respect of the Road Fund;

(ii) in respect of diesel, levies of 0,3 and 8 thebe per litre respectively, payable in respect of the National Petroleum Fund and the Motor Vehicle Insurance Fund, and a levy of 3 thebe per litre in respect of the Road Fund;

(b) at any place specified in the first column of the said Schedule, illuminating paraffin for domestic use, in quantities of a litre or less, at a price not proportionate to that specified in relation to that place in the third column of the Schedule; or

(c) at any place not specified in the first column of the said Schedule, the petroleum product at the head of the —

(i) second column of the Schedule at a price exceeding by more than 12 thebe per litre;

(ii) third column of the Schedule at a price exceeding by more than 11 thebe per litre;

(iii) fourth column of the Schedule at a price exceeding by more than 11.7 thebe per litre;

(iv) fifth column of the Schedule at a price exceeding by more than 12 thebe per litre, the price at which the product was delivered to him.
