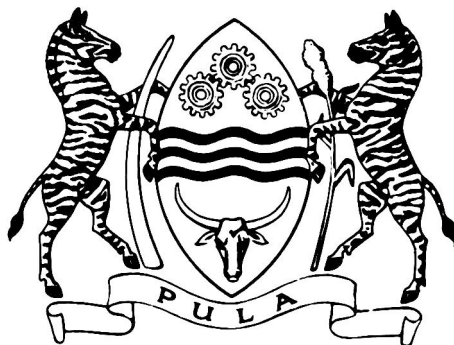

RELOCATION OF NON DIRECTIONAL BEACON TO KASANE AIRPORT

1. Scope and Participation

TENDERS ARE INVITED for the relocation of a decommissioned Southern Avionics Company Non Directional Beacon (NDB) Model SS 2000 from Maun to Kasane Airport. The scope of work under this tender, includes testing of the decommissioned SS 2000 NDB at Maun, dismantling the decommissioned NDB, packaging and transporting the SS 2000 NDB together with a new Antenna Coupler to Kasane Airport. The contract also includes supply of a new Antenna system and NDB Status Indicator, installation, testing and commissioning of the complete NDB system.

**CRIMINAL PROCEDURE AND EVIDENCE (AMENDMENT)
BILL, 1996**

MEMORANDUM

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

The main object of the Bill is to amend the Criminal Procedure and Evidence Act to provide that trials of indecent acts, such as rape, indecent assault on females, defilement of girls under the age of 16, or indecent assault on boys under 14, shall be held in camera. Under the existing law, the courts have discretion to direct that such trials should be held in camera, but most invariably trials of that nature are usually held in public with the attendant publicity which such trials engender. Consequently victims of such offences are reluctant to lay a complaint or to have such offences prosecuted.

The Bill, therefore, proposes to amend section 178 of the Criminal Procedure and Evidence Act to make mandatory provision for the trial of indecent acts mentioned above to be held in camera.

1. This Act may be cited as the Criminal Procedure and Evidence (Amendment) Act, 1996.

2. Subsection (4) of section 178 of the Criminal Procedure and Evidence Act is hereby amended by substituting for that subsection, the following new provisions —

“(4) The High Court may, whenever it thinks fit, and any magistrate’s court, may, if it appears to that court to be in the interest of good or public morals or of the administration of justice, direct that a trial shall be held within closed doors; and the court may direct that all or any persons, not being members or officers of the court or parties to the case, their legal representatives, or persons otherwise directly concerned with the case, be excluded from the court during the trial.

(5) Without prejudice to the provisions of subsection (4), any trial in relation to any of the following offences under the Penal Code, namely rape, attempted rape, indecent assault on any woman or girl, defilement of a girl under the age of 16 years, and indecent assault on a boy under the age of 14 years, shall be held within closed doors.

(6) Where any trial is held within closed doors in accordance with the provisions of subsection (5), the court shall direct that no person shall be present at the sitting of the court except —

- (a) members and officers of that court;
- (b) parties to the case before the court, their legal representatives, and witnesses and other persons directly concerned in the case;
- (c) such other persons as the court may specially authorise to be present.

(7) No newspaper report of the proceedings shall reveal the name, address, or any particulars calculated to lead to the identification of the victim or complainant of the offence, and no picture of the victim or complainant of the offence shall be published in any newspaper.

(8) Nothing in this section shall prohibit the printing or publishing of any matter in a bona fide series of law reports or in a newspaper or periodical of a technical character bona fide intended for circulation among members of the legal or medical professions."
