Authorization to Exercise Functions of Office of the President

TO: THE HONOURABLE FESTUS GONTEBANYE MOGAE M.P., VICE-PRESIDENT, AND MINISTER OF FINANCE AND DEVELOPMENT PLANNING

WHEREAS it is provided by section 36 (1) of the Constitution that whenever the President is absent from Botswana or considers it desirable so to do by reason of illness or any other cause he may, by directions in writing, authorize the Vice-President to discharge such of the functions of the office of President as he may specify, and the Vice-President may discharge those functions until the President's return to Botswana or the revocation of such authorization, as the case may be;

AND WHEREAS I intend to be absent from Botswana from the 11th April, 1997 and I consider it desirable to issue directions as aforesaid;

NOW THEREFORE, in exercise of the powers vested in me as aforesaid I authorize you, FESTUS GONTEBANYE MOGAE in your capacity as Vice-President and Minister of Finance and Development Planning, to discharge with effect from the 11th April, 1997 all the functions of the Office of President, except —

- (a) the power to dissolve Paliament in accordance with the provisions of section 91 of the Constitution;
- (b) the power to appoint to the office of Minister or Assistant Minister in accordance with the provisions of section 42 of the Constitution;

Provided, however, that you can appoint the present Ministers or Assistant Ministers to act in place of any Minister who is otherwise not available;

(c) the power to remove a Minister or Assistant Minister from office in accordance with the provision of section 43 of the Constitution;

until my return to Botswana or this authority is revoked by me whichever happens first.

PALAPYE - MARTIN'S DRIFT ROAD PROJECT

TENDERS ARE INVITED from suitably experienced contractors for the upgrading and surfacing of the road from Palapye to Martin's Drift in the Central District. The works comprise the construction of approximately 81km of main road to bituminous standard. The road runs east-west between the junction with the Gaborone–Francistown Road (A1), approximately 12km south of Palapye, and the existing surfaced road between Sherwood Ranch and Martin's Drift.

Only contractors registered with the Botswana Central Tender Board as Grade D or above under Road sub-code will be considered.

Tenders can be obtained on receipt of a non-refundable bank guaranteed cheque to the amount of P250,00 made payable to the Government of Botswana, from 21st April, 1997 at the offices of the Director of Roads, Roads Department, Private Bag 0026, Gaborone, physical address, Roads Department Headquarters, Plot 4787/4788, Moapare Road, Old Industrial Site, Gaborone, Room No. 106.

A compulsory site inspection will be conducted on Tuesday 6th May, 1997. Prospective tenderers are to meet the Engineer at the Botsalo Travel Inn, Palapye. The site inspection will commence at 8.00 hours whereafter a formal meeting will be conducted in the Roads Department conference room in Gaborone at 8.30 hours on the 7th May, 1997. Written questions for answer at the meeting should be received by the Engineer not later than one week prior to the meeting.

CRIMINAL PROCEDURE AND EVIDENCE (AMENDMENT) ACT, 1997



No. 7

An Act to amend the Criminal Procedure and Evidence Act Date of Assent: 10th April, 1997.

Date of Commencement: 18th April, 1997.

ENACTED by the Parliament of Botswana.

1. This Act may be cited as the Criminal Procedure and Evidence (Amendment) Act, 1997.

2. Subsection (4) of section 178 of the Criminal Procedure and Evidence Act is hereby amended by substituting for that subsection, the following new provisions —

"(4) The High Court may, whenever it thinks fit, and any magistrate's court, may, if it appears to that court to be in the interest of good or public morals or of the administration of justice, direct that a trial shall be held within closed doors; and the court may direct that all or any persons, not being members or officers of the court or parties to the case, their legal representatives, or persons otherwise directly concerned with the case, be excluded from the court during the trial.

(5) Without prejudice to the provisions of subsection (4), any trial in relation to any of the following offences under the Penal Code, namely rape, attempted rape, indecent assault on any woman or girl, defilement of a girl under the age of 16 years, and indecent assault on a boy under the age of 14 years, shall be held within closed doors.

(6) Where any trial is held within closed doors in accordance with the provisions of subsection (5), the court shall direct that no person shall be present at the sitting of the court except —

- (a) members and officers of that court;
- (b) parties to the case before the court, their legal representatives, and witnesses and other persons directly concerned in the case;
- (c) such other persons as the court may specially authorise to be present.

Amendment of section 178 of Cap.08:02

Short title

(7) No newspaper report of the proceedings shall reveal the name, address, or any particulars calculated to lead to the identification of the victim or complainant of the offence, and no picture of the victim or complainant of the offence shall be published in any newspaper.

(8) Nothing in this section shall prohibit the printing or publishing of any matter in a bona fide series of law reports or in a newspaper or periodical of a technical character bona fide intended for circulation among members of the legal or medical professions."
