#### CONSTITUTION OF BOTSWANA

#### Authorization to Exercise Functions of Office of the President

TO: THE HONOURABLE FESTUS GONTEBANYE MOGAE, M.P., VICE-PRESIDENT AND MINISTER OF FINANCE AND DEVELOPMENT PLANNING.

WHEREAS it is provided by section 36 (1) of the Constitution that whenever the President is absent from Botswana or considers it desirable so to do by reason of illness or any other cause he may, by directions in writing, authorize the Vice-President to discharge such of the functions of the Office of President as he may specify, and the Vice-President may discharge those functions until the President's return to Botswana or the revocation of such authorization, as the case may be;

AND WHEREAS I intend to be absent from Botswana from the 1st June, 1997 and I consider it desirable to issue directions as aforesaid;

NOW THEREFORE, in exercise of the powers vested in me as aforesaid I authorize you, FESTUS GONTEBANYE MOGAE in your capacity as Vice-President and Minister of Finance and Development Planning, to discharge with effect from the 1st June, 1997 all the functions of the Office of President, except —

- (a) the power to dissolve Parliament in accordance with the provisions of section 91 of the Constitution;
- (b) the power to appoint to the office of Minister or Assistant Minister in accordance with the provisions of section 42 of the Constitution:

Provided, however, that you can appoint the present Ministers or Assistant Ministers to act in place of any Minister who is otherwise not available;

 (c) the power to remove a Minister or Assistant Minister from office in accordance with the provision of section 43 of the Constitution;

until my return to Botswana or this authority is revoked by me whichever happens first.

## ARRANGEMENT OF BYE-LAWS

### BYE-LAW

- 1. Citation
- 2. Levy of rates
- 3. When rates due and payable

IN EXERCISE of the powers conferred on it by regulation 30 as read with regulation 31 of the Town Council Regulations, and with the approval of the Minister of Local Government, Lands and Housing, the Lobatse Town Council hereby makes the following Bye-Laws -

1. These Bye-laws may be cited as the Lobatse Town Council 1997/98 Rating Bye-law, 1997.

2. The property rates payable in Lobatse Township for the period 1997/98 Levy of rates shall be at the rate of -

(a) 0,60 thebe in the Pula in respect of all improved rateable land used for residential purposes, and 0,75 thebe in the Pula in respect of all improved rateable land used for commercial or industrial purposes;

(b) 2,40 thebe in the Pula in respect of all unimproved rateable land used for residential purposes, and 3,00 thebe in the Pula in respect of all unimproved rateable land used for commercial or industrial purposes.

3. The rates fixed in bye-law 2 shall become due and payable by the person liable to pay such rates, at the commencement of these Bye-laws.
