CONSTITUTION OF BOTSWANA

Authorization to Exercise Functions of the Office of President

TO: THE HONOURABLE FESTUS GONTEBANYE MOGAE, M.P., VICE-PRESIDENT AND MINISTER OF FINANCE AND DEVELOPMENT PLANNING.

WHEREAS it is provided by section 36 (1) of the Constitution that whenever the President is absent from Botswana or considers it desirable so to do by reason of illness or any other cause he may, by directions in writing, authorize the Vice-President to discharge such of the functions of the office of President as he may specify, and the Vice-President may discharge those functions until the President's return to Botswana or the revocation of such authorization, as the case may be;

AND WHEREAS I intend to be absent from Botswana from the 23rd July, 1997 and I consider it desirable to issue directions as aforesaid;

NOW THEREFORE, in exercise of the powers vested in me as aforesaid I authorize you, FESTUS GONTEBANYE MOGAE in your capacity as Vice-President and Minister of Finance and Development Planning, to discharge with effect from 23rd July, 1997 all the functions of the Office of President, except —

- (a) the power to dissolve Parliament in accordance with the provisions of section 91 of the Constitution;
- (b) the power to appoint to the office of Minister or Assistant Minister in accordance with the provisions of section 42 of the Constitution:

Provided, however, that you can appoint the present Ministers or Assistant Ministers to act in place of any Minister who is otherwise not available;

- (c) the power to remove a Minister or Assistant Minister from office in accordance with the provision of section 43 of the Constitution;

until my return to Botswana or this authority is revoked by me which ever happens first.

INDUSTRIAL PROPERTY (AMENDMENT) BILL, 1997

(Published on 1st August, 1997)

MEMORANDUM

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

The object of the Bill is to enhance the provisions of the Industrial Property Act (No. 14 of 1996) to ensure that it complies more fully with the TRIPS Agreement (Agreement on Trade Related Aspects of Intellectual Property Rights).

Clause 3 of the Bill amends section 9 of the Act by including therapeutic and surgical methods for the treatment of humans and animals in the list of matters which, even if they are inventions, will not be protected as patents.

Clauses 4 and 5 amend sections 13 and 22 of the Act by more clearly delineating the requirements as to form and substance of applications for patents. Clause 7 inserts a new provision in the Act to comply with Article 34 of TRIPS which stipulates that in any proceedings for infringement of a patent other than criminal proceedings, where the subject matter of the patent is a process for obtaining a product, the burden of establishing that the product was not made by the process shall, in certain specified circumstances, rest on the defendant.

Clause 11 amends section 81 by extending, to the Republic of South Africa, the transitional provisions of the Act to the owners of patents and industrial designs, and by extending the grace period within which such owners may file applications in Botswana and retain their original filing date or priority date.

(4) (a) The claim or claims shall define the matter for which protection is sought, and the description and any drawings filed may be used to interpret such claim or claims.

(b) The claims shall be clear and concise and shall be fully supported by the description.

(5) The Registrar may require an applicant to file drawings where these are necessary for the understanding of the invention.

(6) The abstract shall not be taken into account for the purpose of interpreting the scope of the protection; it shall merely serve as technical information.

(7) An applicant may, at any time before the patent is granted, withdraw his application."

(b) is the owner of an industrial design registered in the United Kingdom or the Republic of South Africa has filed an application for registration of an industrial design in the United Kingdom or the Republic of South Africa

may, within 20 months of the entry into force of this Act, file an application for the grant of a patent for the same invention or for the registration of the same industrial design under this Act and such application shall be accorded the filing date or priority date accorded to the application, grant or registration in the United Kingdom or the Republic of South Africa."

IN EXERCISE of the powers conferred on the Minister of Finance and Development Planning by section 53(2) (a) of the Income Tax Act, the following Order is hereby made —

1. This order may be cited as the Income Tax (Tax Agreement) Order, 1997. Citation
2. The Tax Agreement entered into between the Minister of Finance and Development Planning on behalf of the Government of the Republic of Botswana and Gallery Resources NL, A.C.N. 009 125 197 and Others is set out in the Schedule hereto — Tax agreement

SCHEDULE

TAX AGREEMENT

THIS AGREEMENT made this 13th day of December 1996 between:

The Minister of Finance and Development Planning on behalf of the Government of the Republic of Botswana ("the Government");

Gallery Resources NL, A.C.N. 009 125 197, a company incorporated in Western Australia and having its registered office at Suite 6, 24 Leura Street, Nedlands, Western Australia ("Gallery");

St Francis Mining NL, A.C.N. 055 719 394, a company incorporated in Western Australia and having its registered office at Level 20, 140 St George's Terrace, Perth Western Australia ("St Francis");

Celtic Trust Company Ltd, of care of Kestrel SA, Pausilippe, Chenin Des Trois-Portes 11.2000 Neuchatel, Switzerland, ("Celtic"); and

Monarch Goldfields Botswana (Pty) Limited ("Monarch");

Shashe Holdings (Pty) Ltd ("Shashe Holdings"); and

Shashe Mines (Pty) Ltd ("Shashe"); all of Private Bag F86, Francistown, Botswana.

WHEREAS:

1. Gallery and St Francis are both public companies listed on the Australia Stock Exchange, and each own 47.5 percent of the shares in Monarch and Shashe Holdings, with Celtic owing the remaining 5 percent. Shashe Holdings owns 85 percent of the shares in Shashe and the Government of the Republic of Botswana owns 15 percent of the shares in Shashe.

2. Gallery, St Francis and Celtic acquired all the shares of Monarch and Shashe Holdings pursuant to an agreement dated 25 May 1994, and took possession of the companies on 24 August 1994, and furthermore that pursuant to the agreement, Gallery, St Francis and Celtic had ceded to them various loans made by the vendors to Mindev and Shashe Holdings.
3. Monarch currently operates a gold mine on Mining Lease 89/2 and holds a prospecting licence 126/94, and Shashe holds Mining Lease 87/3 and is a party to the Map Nora Development Agreement and the Map Nora Development-Tax Agreement, both dated 9 September 1987. Monarch and Shashe are incurring significant exploration and development expenditure in order to establish profitable mining operations on the leases, and require significant financial assistance in the form of loans from Gallery, St Francis and Celtic.
4. It is not the usual practice for mining companies to charge interest on loans to subsidiaries during the exploration and development stages of a mining operation.
5. The parties wish to enter into an agreement in respect to the tax treatment for income tax purposes of certain loans:

NOW THEREFORE the Parties hereto have agreed as follows:

1. That in relation to any loans (and including any loans ceded to any party to this Agreement) owing to any party to this Agreement by Shashe, Shashe Holdings and Monarch where such loans are free of interest and were made for the purposes of carrying out exploration, development and mining operations on Mining Leases 89/2, 87/3 and/or Prospecting Licence 126/94:
 - (a) the provisions of Section 35 of the Act shall not be invoked; and
 - (b) for the purposes of Section 133 of the Act no interest shall be deemed to accrue to any party to the Agreement whilst the loans continue to be used for the purposes of carrying out exploration, development and mining operations on Mining Lease 89/2, 87/3 and/or Prospecting Licence 126/94 and remain outstanding.
2. That no liability to income tax will arise to any party to the Agreement from and by reason alone of the issue of equity shares in Shashe or Mindev to the Government.
3. The effective date of this agreement shall be 24 August 1994.
4. For the purposes of the Agreement Parties shall include any subsidiaries of Gallery, St Francis and Celtic.

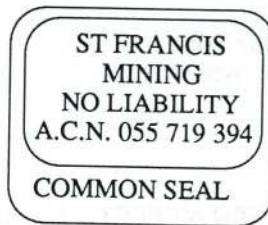
