MINISTERS AND NATIONAL ASSEMBLY GRATUITIES AND PENSIONS BILL, 1998 (Published on 20th February, 1998)

MEMORANDUM

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. The object of the Bill is to make provision for the payment of pensions and gratuities to Ministers, Assistant Ministers, the Speaker and Members of Parliament.

3. It is proposed that gratuities will be paid at the end of every term of Parliament, but that members may opt to receive pensions, in lieu of gratuities, payable after the age of 60, or after leaving Parliament, whichever is the later, or part pensions and part gratuities. Provision is also made for the payment of gratuities to dependants or estates of members who die in office, or who, having left Parliament, die before reaching the age of 60 years.

4. Provision is further made, in order to permit members who wish to draw an enhanced pension at the appropriate time, to contribute 7.5% of their gross annual salary to be paid into the Consolidated Fund.

5. Pensions will be index-linked to the basic salary of an ordinary member of Parliament current at the date when the pension is due.

1. This Act may be cited as the Ministers and National Assembly Gratuities and Pensions Act, 1998, and shall be deemed to have come into operation on the 14th November, 1994.

2. (1) In this Act, unless the context otherwise requires -

"average of constituency allowances" means an amount equal to the average of the aggregate of constituency allowances payable in respect of all the different categories of constituencies specified in paragraph 4 of the Schedule to the National Assembly (Salaries and Allowances) Act;

"basic salary" in respect of a member of the National Assembly means the salary payable to him as such member, and in the case of the Speaker, Deputy Speaker, a Minister or an Assistant Minister includes any salary payable to him in respect of his service as such Speaker, Deputy Speaker, Minister or Assistant Minister:

"member" means a member of the National Assembly, and includes a person deemed to be a member of the National Assembly by virtue of his election as the Speaker thereof, in accordance with the provisions of section 58 of the Constitution.

(2) The provisions of this Act shall apply to all Ministers and Assistant Ministers, and all members, and persons deemed to be members, of the National Assembly in accordance with the provisions of section 58 of the Constitution, other than the President and the Attorney-General.

3. There shall be charged upon and paid out of the Consolidated Fund of Botswana all such sums of money as may from time to time be granted by way of pensions or gratuities in accordance with the provisions of this Act.

4. All pensions or gratuities granted in accordance with the provisions of this Act shall be payable free of tax.

5. Every member shall, upon the dissolution of Parliament, at the end of every Parliamentary term, be entitled to receive a gratuity equal to 30% of the aggregate basic salary paid to him, and average of constituency allowances payable to him, during such term of Parliament.

6. (1) In place of the gratuity payable in accordance with the provisions of section 5, a member may opt to receive a pension calculated in accordance with one of the following, provided that, with effect from the 14th November, 1994 he serves not less than one term in the National Assembly —

(2) In place of the gratuity payable in accordance with the provisions of section 5, a member may opt to receive a pension calculated in accordance with the following, provided that, with effect from the next Parliamentary term, he serves not less than one term in the National Assembly, and provided further that he contributes 7.5% of his gross salary towards the payment of his gratuity or pension, which 7.5% of gross salary shall be withheld from the said salary and paid into the Consolidated Fund —

(a) a member may opt to receive no gratuity, in which case, from the date of his leaving Parliament, or from the age of 60 years, whichever comes later, he shall be entitled to receive a pension equal to 1/300th of the basic salary, and average of constituency allowances, of such member current at the time the pension is payable, for each completed month of service as such member:

Provided that his maximum entitlement shall not exceed 240/300th of such current basic salary and average of constituency allowances;

(b) a member may opt to receive a reduced gratuity of 10% of the aggregate basic salary paid to him, and average of constituency allowances payable to him, during a term of Parliament, in which case, from the date of his leaving Parliament, or from the age of 60 years, whichever comes later, he shall be entitled to receive a pension equal to 1/400th of the basic salary, and average of constituency allowances, of such member current at the time the pension is payable, for each completed month of service as such member:

(c) a member may opt to receive a reduced gratuity of 15% of the aggregate basic salary paid to him, and average of constituency allowances payable to him, during a term of Parliament, in which case, from the date of his leaving Parliament, or from the age of 60 years, whichever comes later, he shall be entitled to receive a pension equal to 1/500th of the basic salary, and average of constituency allowances, of such member current at the time the pension is payable, for each completed month of service as such member:

Provided that his maximum entitlement shall not exceed 240/500th of such current basic salary and average of constituency allowances.

(3) Notwithstanding the provisions of subsections (1) and (2), a member shall not be entitled to be paid a pension at any time if and when he returns as a member of the National Assembly.

7. (1 Any sums of money paid to a member as pension shall, from the date when such member starts to draw the pension, be index-linked to the current basic salary, and average of constituency allowances, of an ordinary member of the National Assembly.

(2) For the purposes of subsection (1), "ordinary member of the National Assembly" means a member, other than the President, the Speaker, Deputy Speaker, a Minister, an Assistant Minister or the Attorney-General, who receives the minimum basic salary, and average of constituency allowances, payable to members in accordance with the National Assembly (Salaries and Allowances) Act.

Pensions to be index-linked age of 60, after having served as such a member —

- (a) for an aggregate period of less than 20 years, shall be paid a lump sum gratuity equal to the basic annual salary, and average of constituency allowances, payable to a member at the time of his death;
- (b) for an aggregate period of 20 years or more, shall be paid a lump sum gratuity equal to three years of the pension that the member would have been entitled to receive had he lived and retired as a member at the age of 60 years, with effect from the date when he died.

9. Upon the death of a member who was over the age of 60 years, and who has retired from service in the National Assembly, his dependents or his estate shall be paid a lump sum gratuity calculated as follows —

- (a) where the death occurs within 10 years of the member's retirement, the equivalent of three years pension at the rate current at the time of his death;
- (b) where the death occurs after 10 years but before 15 years after the member's retirement, the equivalent of two year's pension at the rate current at the time of his death;

PENSIONS (AMENDMENT) BILL, 1998 (Published on 20th February, 1998)

MEMORANDUM

A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. The main objects of the Bill are to amend the provisions of the Pensions Act relating to: (a) forfeiture of retirement benefits on dismissal from the public service for misconduct, (b) the maximum amount of pension payable to a public officer, (c) the maximum amount of gratuity payable to dependents of deceased public officers.

3. Section 6 (1) of the Pensions Act provides that an officer who is dismissed from the public service as a result of disciplinary action taken against him shall not be entitled to any compensation for past services or to any pension, gratuity or other allowances. A public officer is liable to be dismissed from the public service if he is convicted of a criminal offence, however trivial that offence might be. A public officer who has given nearly 40 years of dedicated service to the State is convicted of an offence which is not gravely injurious to the State or is likely to lead to a loss of confidence in the public service, he is dismissed from the public service, serves a term of imprisonment and in addition forfeits all his retirement and other benefits. This is tantamount to "double jeopardy". The officer is being punished more than twice for one single offence committed. Forfeiture of retirement benefits of a public officer should apply only to cases where the offence committed by the officer is considered gravely injurious to the State or likely to lead to a loss of considered gravely injurious to the service of a public officer should apply only to cases where the offence committed by the officer is considered gravely injurious to the State or likely to lead to a loss of confidence in the public service.

4. Clause 2 of the Bill provides for the repeal of section 6 (1) of the Pensions Act, whilst clause 3 provides that forfeiture of retirement benefits shall only apply in cases where the officer has been convicted of very serious or grave offences such as treason or offences under the National Security Act for which he has been sentenced to ten years effective term of imprisonment.

5. Section 7 of the Pensions Act provides that a pension granted to a public officer shall not exceed two-thirds of his highest pensional emoluments at any time while in public service under the Government of Botswana. This provision which puts a ceiling on the amount that a public officer should receive is considered too restrictive, and has, in fact, caused some public officers to retire early from the public service. Similarly section 12 (1) of the Pensions Act which provides for the grant of gratuity to dependants of deceased public officers stipulates that the total amount of gratuity payable shall not exceed the amount of one year's pay. This is considered as unfair.

6. Clauses 2 and 4, therefore, provide for the repeal of section 7 and the proviso to section 12(1), thereby removing the ceiling imposed on the amount of pension or gratuity payable.

7. Clause 5 proposes the amendment of the Pensions Act to provide that gratuity payable to a citizen who is employed on contract for a period of 24 months to 36 months shall be exempt from income tax.

1. This Act may be cited as the Pensions (Amendment) Act, 1998, and

3. Section 10 of the Act is hereby amended by substituting for subsections (1) to (3) thereof, the following new subsections —

10. (1) Where a public officer or former public officer who is entitled to payment of pension, gratuity or other allowance under this Act is convicted of one or more offences, under Part II of the Penal Code (relating to crimes of treason and other offences against the State's authority), or under the National Security Act, for which he has been sentenced to a term of imprisonment of at least 10 years, or has been sentenced on the same occasion to two or more consecutive terms amounting in aggregate to at least 10 years, the President may, if he thinks it is in the public interest to do so, withhold any pension, gratuity or other allowance payable to such officer under this Act.

(2) Where the President decides to withhold any benefits payable under this Act to any officer, he shall give such officer an opportunity to make such representations as the officer may wish to make to him.

(3) Where any benefits are withheld in accordance with the provisions of this section, the President may direct that all or any part of the benefits to which such officer would have been entitled by way of pension, gratuity or other allowance, but for the provisions of this section, should be paid or applied in the same manner in all respects as provided in section 9, and such benefits shall be paid or applied accordingly."
