IN EXERCISE of the powers conferred on the President by section 4 of the Botswana Honours Act, the following Regulations are hereby made ----

1. These Regulations may be cited as the Botswana Honours (Amendment Citation of Schedule) Regulations, 1998.

2. The Schedule to the Botswana Honours Act, is amended by inserting immediately after the last entry therein, the following new entries —

"18. The Botswana Teachers Long and Distinguished Service Award (BTLS), being an honour awarded to members of the teaching profession in Botswana who have distinguished themselves by devoted and exemplary service of at least 30 years.

19. The Botswana Teachers Meritorious Service Award (BTMS), being an honour awarded to members of the teaching profession in Botswana for service of an especially meritorious nature."

3. The Botswana Honours Regulations are hereby amended by the renumbering of the Regulations so as to insert under the appropriate regulation the following new descriptions of Medals —

- (a) (i) The Botswana Teachers Long and Distinguished Service Medal shall be struck in sterling silver in the shape of five-pointed star with a width of 4.3 cm between the ends of alternate points and having a circular disk in the middle of a diameter of 2.2 cm, with the observe consisting, in relief, of the Botswana Coat of Arms and the reserve bearing the words 'For Long and Distinguished Teaching Service'', the names of the recipient and the date of the award.
 - (ii) The medal shall be won on the left breast, pendent from a silver clasp affixed to a silk ribbon 4.3 cm in width and consisting of two sets of vertical stripes in Botswana National Flag colours and in the same proportion as the National Flag. The two sets shall appear adjacent to each other on a yellow background.

- (b) (i) The Botswana Teachers Meritorious Service Medal shall be struck in sterling silver in the shape of the Botswana One Pula Coin released on 23 August, 1976, with the observe consisting in relief, of the Botswana Coat of Arms and the reserve bearing the words 'For Meritorious Service in the Teaching Profession", the names of the recipient and the date of the award.
 - (ii) The medal shall be won on the left breast, pendent from a silver clasp affixed to a silk ribbon 4.3 cm in width and consisting of vertical stripes of black, white and blue ribbon with each colour taking 1/3 of the ribbon.
