THE Government of the Republic of Botswana, Ministry of Works, Transport and Communications — Roads Department, invites contractors to pre-qualify for the construction of the Molepolole-Lephepe Road, Located in the Kweneng District, Botswana.

The project alignment is mainly through Kalahari sands with localised areas of moderately expansive clay soils.
