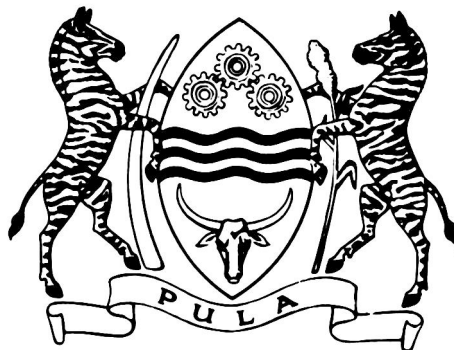

**JUDGES (MISCELLANEOUS PROVISIONS) (AMENDMENT)
BILL, 1998**

(Published on 4th August, 1998)

1. A draft of the above Bill, which it is proposed to present to the National Assembly, is set out below.

2. The object of the Bill is to amend the Judges (Miscellaneous Provisions) Act, 1996, to give effect to the recommendations of the Report of the Presidential Commission on Public Service Salaries and Conditions of Service, 1998.

1. This Act may be cited as the Judges (Miscellaneous Provisions) (Amendment) Act, 1998, and shall be deemed to have come into operation on 1st July, 1998.

2. Section 3 of the Judges (Miscellaneous Provisions) Act, 1996 (in this Act referred to as “the Act”) is hereby amended —
