JUDGES (MISCELLANEOUS PROVISIONS) (AMENDMENT) BILL, 1998

ENACTED by the Parliament of Botswana.

1. This Act may be cited as the Judges (Miscellaneous Provisions) (Amendment) Act, 1998, and shall be deemed to have come into operation on 1st July, 1998.

2. Section 3 of the Judges (Miscellaneous Provisions) Act, 1996 (in this Act referred to as "the Act") is hereby amended —

(a) in subsection (1) by substituting "P9,816" for "P7,848";

- (b) in subsection (2) by substituting in

 - (iii) paragraph (c) "P80" for "P69.48".
