MEMORANDUM

A draft of the above Bill, which it is intended to present to the National Assembly, is set out below.

The object of the Bill is to amend the Local Government (District Councils) Act so as to guarantee the participation of each member of the Council in at least one Council Committee, irrespective of that members' political affiliation. Clause 2 of the Bill amends section 24 of the Act by placing an obligation on the Councils when appointing the various Council Committees, to ensure that every member of a Council belongs to at least one committee.
