WILDLIFE CONSERVATION AND NATIONAL PARKS ACT, 1992 (No. of 1992)

Wildlife Hunting Quota Notice, 2000.

IT IS HEREBY notified for general information that in accordance with section 32 of the Wildlife Conservation and National Parks Act, the Director, after consultation with the appropriate local authorities and land boards, determined the wildlife hunting quota for the year 2000 being game birds and game animals as listed in the First and Second Schedules set out below —

FIRST SCHEDULE

Game Birds

DOVE	15 per da
	Includes Mourning Dove, Redeyed Dove, Cape turtle dove and Laughing Dove
DUCK	10 per da

These daily bag limits are inclusive for each category regardless of the number of species therein. For example, a total of 15 doves may be taken in any given day and this total may be made up of any combination of Mourning dove, Redeyed dove, Cape turtle dove, and/or Laughing dove.

The maximum daily bag limit of game birds is therefore 15 doves, 10 ducks, 10 francolin, 2 geese, 5 guinea fowl, 5 pigeon, 2 quail and 5 sandgrouse.

SECOND SCHEDULE

Game Animals

Small game animals available on license include caracal, bateared fox, silver fox, Cape hare, scrub hare, blackbacked jackal, sidestriped jackal, porcupine, and springhare. These species are subject to an annual bag limit per Small Game License as follows:

CARACAL	2 per license
FOX, BATEARED	5 per license
FOX, SILVER	5 per license
HARE, CAPE	10 per license
HARE, SCRUB	10 per license
JACKAL, BLACKBACKED	
JACKAL, SIDESTRIPED	
PORCUPINE	10 per license
SPRINGHARE	10 per license

The maximum bag limit of small game animals per license per season is therefore two caracal, five bateared fox, five silver fox, ten Cape hare, ten scrub hare, fifty blackbacked jackal, twenty-five sidestriped jackal, ten porcupine and ten springhare for a total possible legal bag of one hundred and twenty small seven game animals.

An exception to the above is the case of leasehold safari areas where small game animals may be taken only under a single game license and only in the numbers as indicated in the annual off-take allocations.

The tables that follow are organized by controlled hunting areas (CHAs) within districts. Those CHAs that are afforded the status of a national park, game reserve, protected area or photographic area are not listed.

Numerical off-take limits are not given for those animals classified as small game except in leasehold safari CHAs. This is because small game licenses are made available only to citizen hunters who may take small game animals in accordance with this notice. Since this is not the case with non-citizen hunters (who may not hold a small game license) a quota is given for these animals which, in leasehold safari areas, must be taken under a single game license by non-citizen hunters.

As regards ostrich, a total allowable off-take (whether by hunting or capture) of adults is given for leasehold safari CHAs and Department of Wildlife and National Parks (DWNP) approved community managed CHAs. Allowable capture off-take of chicks and eggs is provided separately. In all other CHAs only an allowable hunting off-take is given and allowable capture quotas for adults, eggs and/or chicks is listed separately. Conditions for capture will be endorsed on the permit.

A trophy off-take for crocodiles of a total length of 3 metres or greater is given for appropriate CHAs. Capture quotas of eggs or young in addition to the allowable trophy off-take must be obtained separately from the DWNP on a case-by-case basis.

NB*

Elephant quota is made up of -

(a) 50% trophy animals i.e animals which have tusks with a weight of 40 kg and above

(b) 50% non trophy animals i.e animals with tusks which weigh less than 40 kg and those with broken tusks which would otherwise not qualify as trophy animals

IN EXERCISE of the powers conferred on him by section 137(1) of the Income Tax Act, 1995, the Minister of Finance and Development Planning hereby makes the following Order —

- 1. This Order may be cited as the International Financial Services Centre Certification Committee Order, 1999.
 - 2. In this Order, unless the context otherwise requires —

Interpretation

- "Committee" means the International Financial Services Centre Certification Committee;
- "International Financial Services Centre" or "IFSC" means the entirety of international financial services companies and their respective approved financial operations and those institutions which have been appointed to regulate and supervise such companies;

"Marketing Agency" means, for the purposes of marketing the IFSC, the Botswana Development Corporation Limited (BDC); and

"Minister" means the Minister of Finance and Development Planning.

- 3. (1) There is hereby established an IFSC Certification Committee which shall consist of the following ten members to be appointed by the Minister
 - (a) the Secretary for Financial Affairs, who shall be the Chairman of the Committee;
 - (b) the Director, Tax Policy Unit in the Ministry of Finance and Development Planning;
 - (c) the Principal Finance Administrator (Insurance), Ministry of Finance and Development Planning;
 - (d) the Commissioner of Taxes;
 - (e) the Principal Inspector Special Duties and the Secretariat, Department of Taxes:
 - (f) the Director of Financial Institutions Department, Bank of Botswana;
 - (g) the Principal Bank Examiner (Non-bank Operations), Bank of Botswana;
 - (h) the IFSC Project Manager;
 - (i) the Treasurer, Botswana Development Corporation; and
 - (h) the Chief Executive Officer, Botswana Export Development and Investment Authority.

Establishment of IFSC Certification Committee

- (2) The Committee shall appoint, from among its members, a vice-chairman.
- (3) The appointments shall be deemed to have come into effect on the 15th November, 1999 and shall be for a period of two years.
 - (4) The members of the Committee shall be eligible for re-appointment.
- (5) The Minister may appoint such person as he considers appropriate to be the alternate of a specified member of the Committee and may terminate the appointment at any time.
- (6) The alternate of a member of the Committee may, in the event of the absence of that member from a meeting of the Committee, attend the meeting, and shall, when so attending, be regarded as a member of the Committee.

Functions of Committee

- 4. The Committee shall —
- (a) determine the procedures to be followed in the assessment of applications;
- (b) review all applications for a tax certificate referred to it by the Marketing Agency; and
- (c) make recommendations to the Minister in relation to the grant and revocation of tax certificates including any conditions to be attached thereto.

Meetings of Committee

- 5. (1) Subject to the provisions of this Order, the Committee shall regulate its own procedure.
- (2) The Committee shall meet as often as is necessary or expedient for the discharge of its functions, and such meetings shall be held at such places, times and days as the Chairman may determine.
- (3) Six members of the Committee, at least four of whom shall be from the Ministry of Finance and Development Planning, the Department of Taxes, IFSC and Bank of Botswana respectively shall form a quorum.
- (4) The decisions of the Committee shall be by a majority of votes and, in the event of an equality of votes, the Chairman shall have a casting vote in addition to his deliberative vote.
- (5) Minutes of each meeting of the Committee shall be kept and shall be confirmed at a subsequent meeting of the Committee.
- 6. (1) A company applying for a tax certificate shall prepare the application for such certificate in conjunction with the Marketing Agency and the application shall be supported by a business plan for a three to five year period including the following
 - (a) general information on the promoting company, outlining its activities, size, history, performance and principal shareholders, as well as its profit and loss accounts and balance sheets for the past three years;
 - (b) detailed particulars of the activity in respect of which the tax certificate is sought; and
 - (c) summary of the plans to market and promote the proposed service together with an assessment of the potential for employment creation in Botswana.
- (2) The Marketing Agency shall, once satisfied that an application for a tax certificate contains the necessary information, including the information referred to in subparagraph (1), refer the application to the Committee.
