The object of the Bill, which is presented in accordance with the requirements of section 119 (2) of the Constitution and paragraph 6 of the Schedule to the Public Finance Management Act (Cap. 54:01) is to appropriate money from the Consolidated Fund and the Development Fund for the Financial Year ending 31st March, 2019.

1. This Bill may be cited as the Appropriation (2018/2019) Bill. 2018.

2. The Minister of Finance and Economic Development may issue a warrant for the payment from the Consolidated Fund for the year ending 31st March, 2019 of the sum of P63, 339, 069, 280 (Sixty-Three Billion, Three Hundred and Thirty-Nine Million, Sixty-Nine Thousand, Two Hundred and Eighty Pula).

3. The sum authorised by section 2 shall be appropriated to and applied for, the Heads (Organisations) of Expenditure set out in the first and second columns of the Schedule, in the amounts set out in the corresponding entries in the third column of the said Schedule.

4. The Minister of Finance and Economic Development may issue a warrant for the payment from the Development Fund for the year ending 31st March, 2019 of the sum of P19,306,333,840 (Nineteen Billion, Three Hundred and Six Million, Three Hundred and Thirty-Three Thousand, Eight Hundred and Forty Pula).

5. The sum authorised by section 4 is appropriated for, and shall be applied to meet the total amount of expenditure necessary for development projects during the financial year ending 31st March, 2019.
