CONSTITUTION

Summoning a Meeting of National Assembly

WHEREAS it is provided by section 93 (1) of the Constitution that the President may at any time summon a meeting of the National Assembly;

AND WHEREAS a state of public emergency exists;

NOW THEREFORE, in exercise of the powers conferred on me by section 93 (1) of the Constitution, I, Dr. Mokgweetsi Eric Keabetswe Masisi, President of the Republic of Botswana, do hereby summon Parliament to meet and that meeting shall be held at Gaborone, at such time and on such days as the Assembly shall appoint.

State of Public Emergency

PROCLAMATION BY HIS EXCELLENCY

DR. MOKGWEETSI ERIC KEABETSWE MASISI MP, PRESIDENT OF THE REPUBLIC OF BOTSWANA

WHEREAS it is provided by section 17 (1) of the Constitution that the President may at any time declare that a state of public emergency exists;

AND WHEREAS on 11th March, 2020, the World Health Organization declared the COVID-19 outbreak as a "global pandemic";

AND WHEREAS it is necessary to declare a state of public emergency for the purpose of taking the necessary measures to address the risks posed by COVID-19;

NOW THEREFORE in exercise of the powers conferred upon me by section 17 (1) of the Constitution, I, DR. MOKGWEETSI ERIC KEABETSWE MASISI, President of the Republic of Botswana, hereby proclaim and declare a state of public emergency with effect from midnight of 2nd April, 2020.
