THE GHANA BUSINESS CERTIFICATE EXAMINATIONS ORDINARY AND ADVANCED—JULY, 1971

The above examinations which are open to both School and Private candidates will be held for the first time in July, 1971.

2. Entries from private candidates will be accepted up to 30th April, 1971. Applications for entry forms accompanied by crossed 40Np postal or money orders and a foolscap envelope (9" x 4") bearing the applicant's own name and address should be addressed to:—

In their own interest, applicants must write their names and addresses as well as the examination at the back of the postal or money orders.
