### NOTICE OF TAKE-OVER OF PROPERTY FOR THE PUBLIC SERVICE UNDER SECTION 4 OF THE STATE PROPERTY AND CONTRACTS ACT, 1960 (C.A. 6)

WHEREAS section 13 of the Ghanaian Business (Promotion) Act, 1970 (Act 334) provides that no person other than a Ghanaian shall on or after the 30th day of June, 1971 own or be part owner of any enterprise engaged in commercial transportation by land:

AND WHEREAS the Government is concerned to ensure the continued supply to the public of goods and services and in particular the transportation services necessary for that purpose:

AND WHEREAS the Government is also desirous of giving the owners of enterprises engaged in commercial transportation by land and prospective Ghanaian buyers sufficient time and opportunity to enter into negotiations for the due purchase and take-over of such enterprises by Ghanaians in pursuance of the provisions of section 13 of the Ghanaian Business (Promotion) Act, 1970 and without causing hardship to the public:

Now THEREFORE in exercise of the powers conferred on the President by section 4 of the State Property and Contracts Act, 1960 (C.A. 6), notice is hereby given as follows:—

1. That all enterprises owned and operated for commercial transportation by land, by the companies, firms and businesses specified in the Schedule to this Notice (including all properties employed in connection with any such enterprise) are hereby declared to be required for the Public Service.
2. That with effect from the 1st of July, 1971 and until the completion of negotiations for the transfer of such enterprises to Ghanaians in pursuance of section 13 of the Ghanaian Business (Promotion) Act, 1970, Government will take over the possession, control and operation of the said enterprises in the public interest.
