### EXPORT BONUS SCHEME REGULATIONS—THE FOREIGN EXCHANGE (EXPORT BONUS) ACT, 1970

1. The Export Bonus Scheme shall apply to all products originating from Ghana with the exception of the following:—
  - (a) Timber and its derivatives but excluding plywood and furniture.
  - (b) Cocoa and its derivatives.
  - (c) All minerals and primary metals.
2. Notwithstanding paragraph 1 above, exports of timber and its derivatives including plywood and furniture, fabricated metals and cocoa derivatives to African countries shall qualify for the bonus.
3. All claims should be made at the Bank of Ghana or its authorised Agents.
4. All exporters will be requested to complete at their banks or authorised institutions, the usual Exchange Control forms.
5. Such forms shall be endorsed by the Ghana Bank or its authorised agent upon receipt of Shipping or appropriate documents supplied by the exporter.

6. For the purpose of implementing the scheme the Bank shall keep a record of the export performance of individual exporters.

- (a) The bonus which shall be paid in Ghana currency shall be assessed on the total value of exports computed as the cedi equivalent of the foreign exchange proceeds surrendered to the Bank of Ghana.
- (b) The Bank of Ghana or its authorised agents shall upon application by an exporter pay the bonus which in the 1970-71 and 1971-72 fiscal year shall be 25 per cent of the value of exports expressed in cedi equivalent.
- (c) The exporter shall be paid the bonus upon presentation to the Bank of Ghana or its authorised agents of a photostat copy of the Bank Advice indicating that the foreign exchange proceeds have been duly surrendered to the Bank of Ghana.
- (d) Before effecting payment the Bank of Ghana or its authorised agents shall ensure that the export proceeds have actually been repatriated.

7. To claim the bonus for the 1969-70 financial year it will be sufficient for the exporter to prove to the Bank of Ghana or its authorised agents with Shipping and other documents that he has exported some goods in respect of which the bonus scheme applies during 1969-70.

8. The Bank of Ghana shall verify these claims against their own records.

9. For the purpose of section 9 of the Act, the following external currencies shall be regarded as convertible in fact:

- (a) All African currencies.
- (b) The currencies defined by the International Monetary Fund as convertible in fact.
