AFRICAN TRANSFER STUDENT AWARDS PROGRAMME (ATSA) 1972-73 AWARDS

It is proposed to award a number of Scholarships for degree courses in Forestry, Dentistry, Veterinary Medicine, Librarianship and B.A. (Hons.) French, under the African Transfer Student Awards Programme. The awards are tenable in African Universities.

2. Applications are invited from suitably qualified Ghanaians who would not have reached their 27th birthday by 1st October, 1972.

Qualification:

- (a) *Forestry*—at University of Ibadan, Nigeria. Candidates must have passed in at least five subjects, including English Language and Mathematics at G.C.E. 'O' Level with two of either Physics, Mathematics, Chemistry, Botany or Zoology at 'A' Level.
- (b) *Dentistry*—at University of Lagos, Nigeria and Lovanium University, Congo Kinshasa. Candidates must have passed in at least five subjects, including English Language, Mathematics at G.C.E. 'O' Level and two 'A' Level subjects selected from Chemistry, Physics, Botany or Biology. Those who will be selected for Lovanium University must have passed in French at the G.C.E. 'O' Level.
- (c) *Veterinary Medicine*—at the University of East Africa, Nairobi and Ahmadu Bello University, Zaria, Nigeria and Khartoum University. Candidates must have passed in at least five subjects at G.C.E. 'O' Level with two 'A' Level passes in Physics, Chemistry, Botany, Zoology.
- (d) *Librarianship*—at Ahmadu Bello University, Zaria, Nigeria. Candidates must be graduates who must be first degree holders and who will take Librarianship as a career.
- (e) *Licentiate B.A. (Hons.) French Degree*—at Dakar, Abidjan and Yaounde Universities. Candidates must have passed in at least five subjects at G.C.E. 'O' Level including French and English Language and two 'A' Level subjects in French and one other Language.

3. Students who already possess the 'A' Level Certificate are eligible.

Applications.—Preliminary application should be by letter confirming qualification as indicated above and giving details of G.C.E. marks obtained. Letters which should be marked ATSA/Forestry, ATSA/Dentistry, ATSA/Veterinary, etc., as the case may be should reach The Registrar of Scholarships, P.O. Box M.75, Accra, not later than 25th October, 1971.

COMBINED EXAMINATION FOR ENTRY TO FOUR-YEAR TEACHER TRAINING COLLEGES AND FOR PUPIL TEACHERS' SELECTION, 1972

The above examination will be held on February 11, 1972. Applicants for entry forms will be required to pay an amount of two new cedis and fifty new pesewas (N¢2.50) before they are issued with the forms. This amount, which includes both the entry fee and the price of the entry form, must be paid by Postal or Money Order, crossed and made payable to "The West African Examinations Council". In their own interest, applicants must write their name and address at the back of the postal or money order. The Council accepts no responsibility for the loss of postal orders which are not completed in accordance with these instructions. Stamps, cash and cheques are not accepted.

2. Once the entry fee is paid, there will not be any refund. A candidate who decides at a later stage to withdraw his entry or whose entry is cancelled because he fails to complete the form according to the instructions, will *not* have the fee refunded to him. Therefore, before applying for entry forms, applicants should make sure that they are eligible for the examination, and that they do not intend to withdraw at a later stage. They must also make sure that the entry forms are completed strictly in accordance with the instructions and returned to the Senior Deputy Registrar as quickly as possible.

Applications are invited from suitably qualified West Africans for appointment as Assistant Registrars and Research Officers.

Applicants should be honours graduates in any of the subject areas listed below, and should have at least three years' working experience in Administration or Education since graduation. The subject areas are:

Statistics, History, Mathematics, Chemistry, Physics and Biology.

The successful candidates must be prepared to serve in any of the Council's Offices in Accra, Freetown, Lagos and the Local branch offices in Enugu, Kaduna, Kano and Kumasi.

3. Persons applying for forms by post must enclose an envelope 6" x 3½" to which a five new pesewa (5Np) stamp has been affixed and which bears the candidate's full name and correct postal address in bold capitals. The candidate's Region must be stated in the address.

4. *Eligibility.*—Candidates eligible to enter for this examination are:

- (a) holders of the Middle School Leaving Certificate;
- (b) pupils who have completed a minimum of two years' attendance in an approved secondary school or three years in a private secondary school;
- (c) Middle School Leavers who are awaiting the results of the Middle School Leaving Certificate Examination held in August, 1971;
- (d) pupils who are due to take the Middle School Leaving Certificate Examination in August, 1972.

5. *Method of Entry*—

- (a) In the Northern and Upper Regions candidates should apply to their respective District Education Officers for forms.
- (b) In all other regions applicants may:

GOVERNMENT SECRETARIAL SCHOOLS VACANCIES FOR ASSISTANT INSTRUCTORS

Applications are invited from suitably qualified persons for appointment to the pensionable grade of Assistant Instructor, Government Secretarial Schools.

Salary Scale.—Range 45, i.e. N¢1,488 x N¢60–N¢1,668 x N¢72–N¢1,740.

Duties.—Tuition in Shorthand, Typewriting, Office Administration and Secretarial Practice; assistance in conducting grading examinations and secretarial duties connected with administration of the Schools.

Qualifications.—Candidates must—

- (i) not be more than 40 years of age and must not be below the grade of Stenographer Grade II;
- (ii) have obtained Credit in the English Language paper at the West African School Certificate or passed in the English paper at the General Certificate of Education, Ordinary Level, or passed the Qualifying English Examination set by the West African Examinations Council;
- (iii) have passed shorthand test at the rate of 110 words per minute for 5 minutes.
- (iv) (a) have passed Accuracy/Speed test in Typewriting at the rate of 50 words per minute for 10 minutes; and
(b) typewriting from manuscript.
- (v) have passed a test in Elementary Secretarial Practice;
- (vi) have five years' clerical, secretarial and/or teaching experience, preferably in commercial subjects;
- (vii) possess an aptitude for teaching.

(A special test will be arranged for candidates who do not possess the specified qualifications mentioned in sub-paragraphs (ii) to (v) but are qualified in other respects.)

Application forms may be obtained from the Secretary, Public Services Commission, P.O. Box 1618, Accra, to whom they should be returned not later than 31st October, 1971. Serving officers are advised to submit their applications through their Heads of Departments. Candidates under any form of bond are ineligible.
