## JUDICIAL SERVICE

## VACANCIES FOR DISTRICT MAGISTRATES GRADE I

Vacancies exist in the Judicial Service for District Magistrates Grade I.

2. *Qualification*.—Applicants must be Ghanaians, enrolled on the Roll of Lawyers in Ghana, and be of, at least, three years' standing as legal practitioners.

3. *Salary*.—The salary scale attached to the post which is pensionable, is £4,000 x £200–£6,000. Candidates with (a) a University Degree plus three years' experience or (b) five years' professional experience without a University Degree will be entitled to commence at £4,000.

4. *Duties*.—These include the trial of cases both criminal and civil, conducting preliminary enquiries in more serious criminal cases, acting as Coroners and *ex officio* Commissioners for Affidavits and as Notaries Public, and also being responsible for preparation of lists of Jurors.

*Method of Application*.—Forms are obtainable from the Judicial Secretary, Judicial Service, Law Courts Building, P.O. Box 119, Accra. These should be completed and returned not later than 21st of February, 1973. Candidates in any of the Public Services should apply through their Heads of Departments. Only copies of supporting documents may be forwarded. Persons under any form of bond are not eligible.

## JUDICIAL SERVICE

## VACANCIES FOR DISTRICT MAGISTRATES GRADE II

Vacancies exist in the Judicial Service for District Magistrates Grade II.

## (i) PROFESSIONAL

*Qualifications*.—Applicants must be Ghanaians on the Roll of Lawyers in Ghana and be of, at least, 18 months' standing as legal practitioners. The post, which is pensionable, carries the following salary scales:—

*Salary*.—(a) Candidates with University Degree: £3,800 x £100–£4,000 x £200–£5,000; and

(b) Candidates without University Degree: £3,600 x £100–£4,000 x £200–£5,000. Successful candidates may be considered for promotion to District Magistrates Grade I when they so qualify.

## (ii) NON-PROFESSIONAL

*Qualifications*.—Candidates must be Ghanaians holding at least the School Certificate or equivalent educational qualification or must be persons in the upper Executive Grade or have once been in that Grade in the Public Service. They must have some elementary knowledge of the duties of a District Magistrate and the laws applicable thereto. They must be of good reputation and character. Candidates must not be below the age of 40. Legal practitioners with 6 to 18 months' post-call experience may be considered for appointment as Magistrates in this category until they qualify for appointment under (i) above.

*Salary*.—The post is non-pensionable and carries a salary of £2,400 per annum flat. The appointment will initially be on contract for 2 years but will be renewable yearly subject to good work, report and conduct until the appointee reaches the age of 60 (or 65 in exceptional cases).

*Duties*.—The duties of both the Professional and non-Professional Magistrates include trial of Criminal and Civil cases within the jurisdiction conferred under the Courts Act, 1971, acting as Coroners and supervising the preparation of lists of Jurors.

*Method of Application*.—Application Forms are obtainable from the Judicial Secretary, Judicial Service, Law Courts Building, P.O. Box 119, Accra. These should be completed and returned not later than the 21st of February, 1973. Candidates in the Public Services should apply through their Heads of Ministries or of Departments, etc. Only copies of supporting documents may be forwarded.

**GAZETTE NOTICE UNDER SECTION 9 OF THE INSURANCE (AMENDMENT) DECREE, 1972**

In exercise of the powers conferred on the Commissioner responsible for Finance by section 9 of the Insurance (Amendment) Decree, 1972 (N.R.C.D. 95), it is hereby directed as follows:—

- (a) that section 9 of the said Decree shall apply only to insurance effected by the Government or a statutory corporation or by any body in which the Government or a statutory corporation owns more than 50 per cent of the proprietary interest, and also to insurance effected in respect of any property or interest held by or in trust for the Government, a statutory corporation or any such body;
- (b) that any insurance referred to in paragraph (a) above may with the prior approval of the Commissioner responsible for Finance be effected through an intermediary being the National Finance and Merchant Bank Limited or any insurance broker or an insurance agent wholly owned by all or any of the following:—

The Government, a statutory corporation, a citizen of Ghana, any company or partnership wholly owned by all or any of the foregoing.
