NOTICE FOR REGISTRATION WITH THE MEDICAL AND DENTAL COUNCIL

All medical and dental practitioners are hereby notified, for purposes of registration, that they are required to submit their names, address, qualification with dates, nationality by the 17th March, 1973 to :

2. The particulars are required for the preparation of a register which will be used as the voters list for the voting of members to the Medical and Dental Council in accordance with section 2 (a) and (b) of the Medical and Dental Decree, 1972.

3. No person shall be registered under the Medical and Dental Decree, 1972 unless he is a member of the Ghana Medical Association, and pays the prescribed registration fee to the Medical and Dental Council.

4. *Registration.*—Practitioners may be registered as follows:—

- (a) On the standing register for those who have satisfied the prescribed conditions, and on payment of the fee of Fifty cedis. ₵50.00
- (b) On the provisional register for those employed in a resident medical or dental capacity (e.g. Housemen) in an approved hospital or institution, and on payment of the fee of Ten cedis. ₵10.00
- (c) On the temporary register for those who are required by the Council to serve a period of mandatory vocational training, and on payment of the fee of Ten cedis. ₵10.00
- (d) On the temporary register for those who would qualify for the standing register but who are ineligible since they do not intend to practise permanently in Ghana, and on payment of the fee of Fifty cedis. ₵50.00

5. Section 32 of the Medical and Dental Decree, 1972 (N.R.C.D. 91) states:

“A copy of the list published in accordance with section 28 shall be evidence in all proceedings that the persons specified therein are registered under this Decree; and the absence of any person from any copy of the list shall be evidence, until the contrary is shown, that he is not registered under this Decree.”
