

## LABOUR DEPARTMENT

## VACANCIES FOR THE POST OF ASSISTANT LABOUR INSPECTORS

Applications are invited for the post of Assistant Labour Inspectors in the Labour Department.

**Duties.**—The duties of an Assistant Labour Inspector, include, the investigation of labour complaints, the recovery of unpaid wages, the preparation of court cases regarding unpaid wages and appearance in court on behalf of workmen. The investigation of workmen's compensation claims and the circumstances from which they arose, and the assistance of claimants, if necessary, before the court. The inspection of places of employment and/or of the living conditions of workers, and submission of reports. The enforcement of Wages Boards Orders. The giving of advice and assistance to trade unions; administration of a small Labour Office and/or Youth Employment Centres including liaison with prospective employers, offering advice to school leavers, vocational guidance and assistance in obtaining employment by the unemployed.

Generally assist Labour Inspectors, Senior Labour Inspectors and Labour Officers in advising employers and employees on labour matters and in connection with trade disputes.

*Qualifications:*

- I. (i) G.C.E. 'A' Level Certificate; or
  - (ii) Must have passed the Executive Officers' examination; or
  - (iii) G.C.E. 'O' Level Certificate with 3 Credits including English Language.
- II. Applicant should not be more than 25 years of age.

**Salary.**—Applicants with G.C.E. 'O' Level Certificate will undergo training for two years and will be paid training allowance of ₦672 per annum during the first year and ₦708 per annum during the second year after which they would be confirmed as Assistant Labour Inspectors.

Assistant Labour Inspector is on salary range R. 27, 32. i.e. ₦1,116–₦1,476 per annum.

**Method of Application.**—Application forms are obtainable from the nearest Regional Labour Officer to whom the completed application forms should be returned not later than 30th June, 1976.

## ARCHITECTURAL AND ENGINEERING SERVICES CORPORATION

VACANCIES FOR TECHNICAL OFFICERS—HYDROLOGY, QUANTITY SURVEYING,  
LABORATORY AND DRAUGHTSMANSHIP

Applications are invited from suitably qualified persons to undergo a course of Training in Hydrology, Quantity Surveying, Laboratory and Draughtsmanship. Approximately half the Training period would be spent in the field and the other half at the Architectural and Engineering Services Corporation Training School at Weija.

2. *Qualifications*

Candidates must:

- (a) possess WASC/GCE "O" Level with at least 3 passes including English Language, Mathematics, Physics and Chemistry.

3. *Entrance and Medical Examination.*—Suitable applicants will be selected after an entrance examination and interview. Selected candidates must have a certificate of fitness from a Government Medical Officer before they will be accepted for the Training.

4. *Allowances.*—Selected candidates will be paid a Training allowances of ₦948 per annum for the first year, ₦984 per annum for the second year and ₦1,020 per annum for the final year.

5. *Bonding.*—Students will be bonded to the Architectural and Engineering Services Corporation in the sum of One thousand, five hundred cedis (₦1,500) to complete the course and to serve the Corporation for five years.

6. *Accommodation and Messing.*—Furnished accommodation and services are provided in the school. Students are required to pay for the cost of messing.

7. *Appointment.*—Students who successfully complete the course will be eligible for appointment to the grade of Technical Officer on the salary scale ranges, 40, 45 (₦1,668–₦2,244) with prospects of promotion to higher post in the Corporation.

8. *Methods of Application.*—Applications which should be in candidate's own handwriting, stating age, qualifications including detail results of General Certificate of Education, Ordinary Level Examination (and experience, if any) should be addressed to the Chief Consultant, Architectural and Engineering Services Corporation, Post Office Box 3969, Accra, to reach him not later than 28th May, 1976. Copies (not originals) of certificates or detailed results and also of testimonials should be attached to the application.

9. Applicants under any form of bond are ineligible.

**JUDICIAL SERVICE****VACANCIES FOR DISTRICT MAGISTRATES GRADE I**

Vacancies exist in the Judicial Service for District Magistrates Grade I.

**Qualification.**—Applicants must be Ghanaians, enrolled on the Roll of Lawyers in Ghana, and be of at least 3 years' standing as legal practitioners.

**Salary.**—The salary scale attached to the post which is pensionable, is ₦4,368 x ₦132—₦5,676 x ₦156—₦5,832 x ₦168—₦6,504. Candidates with (a) a University Degree plus three years' experience or (b) five years' professional experience without a University Degree will be entitled to commence at ₦4,368.

**Duties.**—These include the trial of cases both criminal and civil, conducting preliminary enquiries in more serious criminal cases, acting as Coroners and *ex-officio* Commissioners for Affidavits and as Notaries Public, and also being responsible for preparation of lists of Jurors.
