SOUTH LEGON DEVELOPMENT SCHEME (REVISED)

- 3. The Acera Metropolitan Planning Committee has on behalf of the Acera Metropolitan Assembly, considered the Scheme and recommended it for the affirmation of the Minister responsible for Town & Country Planning.

The South Legon Development Scheme (Revised) is located on the north-west quadrant of the Tetteh Quarshie Circle and accessed by the Accra-Madina road on the north-east and the Accra-Tema Motorway Extension on the south. The Scheme has been revised in order to intensify and maximise the use of the land, and to relocate incompatible uses to provide for the growing demand for land for government, institutional and private sector uses. It also creates an area strategic to the development and growth of the Accra metropolis offering an alternative to central business functions and viable commercial investment opportunities in land development.
