PUBLICATION OF ELECTRICITY TARIFFS**

In accordance with the statutory duty to publish rates approved by the Public Utilities Regulatory Commission under Section 19 of the Public Utilities Regulatory Commission Act 1997 (Act 538), this publication is made this 27th May 2011.

1. The Volta River Authority (VRA) and the Sunon Asogli Power (Ghana) Ltd. (Asogli) shall charge the rates provided for in the First Schedule hereto as Bulk Generation Charge (BGC) and Generation Charge (GC) to take effect from 1st June 2011.
2. The Ghana Grid Company Limited (GRIDCo) shall charge the rates provided in the Second Schedule hereto as the Transmission Service Charge (TSC) to take effect from 1st June 2011.
3. The Electricity Company of Ghana Limited (ECG) and Northern Electricity Department (NED) of the VRA shall charge the rates provided for in the Third and Fourth Schedules hereto as the Distribution Service Charge (DSC) and End-User Tariffs to take effect from the June 2011 billing cycle.
4. The rates are denominated in Ghana Pesewas.
5. These approved rates shall remain in force until they are changed by the Public Utilities Regulatory Commission.
6. Until the next major tariff review, electricity tariffs shall be adjusted as per the automatic adjustment (indexation) formula published in Gazette No. 15 of 25th February 2011.
