PUBLIC UTILITIES REGULATORY COMMISSION (PURC) PUBLICATION OF ELECTRICITY TARIFFS

In accordance with the statutory duty to publish rates approved by the Public Utilities Regulatory Commission under Section 19 of the Public Utilities Regulatory Commission Act 1997 (Act 538) ("the Act"), this publication is made this 23rd December 2013.

1. The Volta River Authority (VRA) shall charge the rates provided in the First Schedule hereto referred to as "BGC VRA" as the Bulk Generation Charge to take effect from 1st January 2014.
2. The Ghana Grid Company Limited (GRIDCo) shall charge the rates provided in the Second Schedule hereto referred to as the Transmission Service Charge to take effect from 1st January 2014.
3. The Electricity Company of Ghana Limited (ECG) and Northern Electricity Distribution Company Limited (NEDCo) shall charge the rates provided in the Third and Fourth Schedules hereto referred to as the Distribution Service Charge and End-User Tariffs to take effect from the January 2014 billing cycle.
4. The rates are denominated in Ghana Pesewas.
5. These approved rates shall remain in force until they are changed by the Public Utilities Regulatory Commission.
6. Until the next major tariff review, electricity tariffs shall be adjusted as per the automatic adjustment (indexation) formula published in Gazette No. 15 of 25th February 2011.
7. The rates approved by the Public Utilities Regulatory Commission to take effect from 1st October 2013 as published in Gazette No.84 of Wednesday, 2nd October 2013, are revoked and replaced with the rates published in the First, Second, Third and Fourth Schedules hereto.
