STATUTORY DECLARATION

IN THE MATTER OF THE STATUTORY DECLARATION ACT, 1971 (ACT 389)

AND

**IN THE MATTER OF A STATUTORY DECLARATION BY THE ASIENIMPONG
TRADITIONAL COUNCIL**

AND

IN THE MATTER OF NOTICE OF CHANGE IN THE SPELLING OF NAME

WE, THE UNDERSIGNED, being the head and principal members respectively of the Asienimpong Traditional Council in the Ejisu-Juaben District of the Ashanti Region in the Republic of Ghana do hereby solemnly and sincerely declare:-


1. That we are the Declarants herein.
2. That we are the head and principal members respectively of the ASIENIMPONG TRADITIONAL COUNCIL.
3. That the name ASIENIMPONG had hitherto been generally spelt "ESSIENIMPONG".
4. That we hereby give notice to all and sundry that we have formally and absolutely renounced and abandoned the spelling "ESSIENIMPONG" as the town's name in all instruments, writings and documents as well as dealings and transactions by the Traditional Council.
5. That in its place, we have assumed and adopted the spelling "ASIENIMPONG" in all instruments, writings and documents as well as dealings and transactions by the Traditional Council.
6. That all instruments, writings, documents as well as dealings and transactions directed at or to the Traditional Council shall be received under the spelling "ASIENIMPONG" and none other.
7. That the adoption of this new spelling shall be without prejudice to and shall not invalidate any deed or document executed by the Traditional Council or proceedings entered unto under the former spelling of the town's name or any rights accrued to the Traditional Council or obligations incurred by it under the former spelling of the town's name.

WHEREFORE, we make this solemn declaration conscientiously believing it to be true in accordance with the Statutory Declarations Act 1971 (Act 389).


